

FISHERIES (DECLARATION OF NEW STOCK SUBJECT TO QUOTA MANAGEMENT SYSTEM) NOTICE 1997

PURSUANT to section 28B of the Fisheries Act 1983, the Minister of Fisheries gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Fisheries (Declaration of New Stock Subject to Quota Management System) Notice 1997.
- (2) This notice comes into force on the day after the date of its notification in the Gazette.
 - 2. Interpretation—In the Schedule of this notice,—
 - (a) Except as provided in paragraphs (b) and (c), the quota management areas referred to by a reference number are the fisheries management areas described by reference to the same number in Part I of the First Schedule of the Fisheries Act 1996:
 - (b) In the case of scampi, the references to quota management areas 6A and 6B are to be read as references to the quota management areas referred to by the same numbers in the Second Schedule of the Fisheries (Reporting) Regulations 1990*:
 - (c) In the case of southern blue whiting, the reference to quota management area 6B is a reference to Bounty Platform, the reference to quota management area 6I is a reference to Campbell Island Rise, and the reference to quota management area 6P is a reference to Pukaki Rise, which areas are described in clause 2 of the Fisheries (Southern Blue Whiting Commercial Catch Limit) Notice 1997†:
 - (d) The references to fishstocks and fishstock codes are references to the fishstocks and fishstock codes specified in Table 1 of the Second Schedule of the Fisheries (Reporting) Regulations 1990.
- **3.** New stocks to be subject to quota management system—(1) Except as provided in subclause (2), the stocks specified in the Schedule are subject to the quota management system established under Part IIA of the Fisheries Act 1983 on and from 1 October 1998 in the quota management areas specified in that schedule.

(2) Southern blue whiting is subject to the quota management system established under Part IIA of the Fisheries Act 1983 on and from 1 April 1999 in the quota management areas specified in the Schedule.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the Gazette, adds 11 new stocks to the quota management system established under Part IIA of the Fisheries Act 1983.

On and from 1 October 1998, scampi, cardinal fish, frostfish, ghost shark, ribaldo, ruby fish, sea perch, trumpeter, white warehou, and yellow-eyed mullet are subject to the quota management system. The notice does not apply to cardinal fish in areas 1 and 9.

On and from 1 April 1999, southern blue whiting is subject to the quota management system.
