# THE FOREST PRODUCE IMPORT AND EXPORT REGULATIONS 1966, AMENDMENT NO. 10

## ORDER IN COUNCIL

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Forests Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Forest Produce Import and Export Regulations 1966, Amendment No. 10, and shall be read together with and deemed part of the Forest Produce Import and Export Regulations 1966\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.

- 2. Amount of goods and services tax included—The principal regulations are hereby amended by adding the following regulation:
- "31. The charges set out in the Third Schedule to these regulations are inclusive of goods and services tax imposed under the Goods and Services Tax Act 1986, at the rate of 10 percent."
- **3. Third Schedule**—(1) The principal regulations are hereby amended by revoking the Third Schedule (as substituted by regulation 4 of the Forest Produce Import and Export Regulations 1966, Amendment No. 9), and substituting the new Third Schedule set out in the Schedule to these regulations.
- (2) The Forest Produce Import and Export Regulations 1966, Amendment No. 9, is hereby amended by revoking regulation 4 and the Schedule.

COST OF INSPECTING FOREST PRODUCE

1. Forest produce imported by sea—The cost of inspecting	forest

(a) For forest produce in sawn or round form, per cubic metre	3.90
(b) For inspections in relation to bulk cargo containers—	
(i) For each full container load	8.40
(ii) For each landed bulk cargo container declared 'empty' or 'MT'	1.90
(iii) For each other bulk cargo container load, per tonne or part thereof	3.10
(c) For each landed item of forest produce not charged, per tonne or part thereof	2.00
<b>2. Forest produce exported</b> —The cost of inspecting forest produce exported from New Zealand shall be—	duce to
(a) For forest produce to be exported from the Port of Tauranga in round form, per cubic metre	
in round form, per cubic metre	0.40
(b) For forest produce to be exported from all other ports in	
round form, per cubic metre	0.50
(c) For forest produce in sawn form, per cubic metre	0.60
(d) For forest produce not in sawn or round form, per consignment	27.50"

## **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the 28th day after the date of their notification in the Gazette, amend the Forest Produce Import and Export Regulations 1966 by—

(a) Substituting a new Third Schedule for charges of inspecting forest produce; and

(b) Providing that goods and services tax is included in the charges set out in the Third Schedule.
