ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 72 of the Forests Act 1949, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations, may be cited as the Forest Produce Import and Export Regulations 1989, Amendment No. 4, and shall be read together with and deemed part of the Forest Produce Import and Export Regulations 1989* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

2. Fees—The Second Schedule to the principal regulations (as substituted by regulation 4 (1) of the Forest Produce Import and Export Regulations 1989, Amendment No. 2 and as amended by regulation 2 of

the Forest Produce Import and Export Regulations 1989, Amendment No. 3) is hereby amended by revoking clause 1, and substituting the following clause:

"1. Forest produce imported by sea—The costs of inspecting forest produce imported by sea shall be—

"(a) For forest produce in sawn or round form, per cubic	
metre	5.94
"(b) For inspections in relation to bulk cargo containers—	
"(i) For each FCL	11.35
"(ii) For each LCL, per revenue tonne or part thereof	3.42
"(c) For inspections in relation to other cargo not charged, for	
"(c) For inspections in relation to other cargo not charged, for each landed item, per revenue tonne or part thereof	0.42".

3. Revocation—The Forest Produce Import and Export Regulations 1989, Amendment No. 3 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force 28 days after the date of their notification in the *Gazette*, amend the Forest Produce Import and Export Regulations 1989.

- The regulations increase inspection fees as follows:
- (a) For forest produce in sawn or round form, the fee is increased from \$5.04 to \$5.94 per cubic metre:
- (b) For inspections in relation to bulk cargo containers-

(i) For each FCL, the fee is increased from \$9.63 to \$11.35:

(ii) For each LCL, the fee is increased from \$2.90 to \$3.42 per revenue tonne or part thereof:

(c) For inspections in relation to other cargo not charged, the fee for each landed item is increased from 36 cents to 42 cents per revenue tonne or part thereof.
