THE FISHERIES (SQUID QUOTA MANAGEMENT AREAS, TOTAL ALLOWABLE CATCHES, AND CATCH HISTORIES) NOTICE 1987

PURSUANT to sections 28B and 28C of the Fisheries Act 1983, the Minister of Fisheries, acting after consultation with the Fishing Industry Board, and after allowing for the matters specified in section 28c, hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Fisheries (Squid Quota Management Areas, Total Allowable Catches, and Catch Histories) Notice 1987.
- (2) This notice shall come into force on the day after the date of its notification in the Gazette.
 - 2. Interpretation—(1) In this notice—
 - "The Act" means the Fisheries Act 1983:
 - "Jigging" means any fishing method for taking squid by means of a line rather than a net:
 - "Kermadec Area" means all New Zealand fisheries waters within the Kermadec Fishery Management Area, including all inland waters of any island within that area:
 - "Southern Islands Area" means all New Zealand fisheries waters—
 - (a) Enclosed by a line commencing at a point 49°30'S and 165°E; then proceeding due east to a point 49°30'S and 168°E; then proceeding due south to a point 51°30'S and 168°E; then proceeding due west to a point 51°30'S and 165°E; then proceeding due north to the point of commencement; or
 - (b) Enclosed by a line commencing at a point 51°30'S and 168°E; then proceeding due east to a point 51°30'S and 171°E; then proceeding due south to a point 53°30'S and 171°E; then proceeding due west to a point 53°30'S and 168°E; then proceeding due north to the point of commencement:
 - "Squid" means the fish of which the scientific name is Nototodarus sloani or Nototodarus gouldi, commonly known as arrow squid.
- (2) In this notice a reference to a named fishery management area is a reference to the area of that name as defined in the notice published in the *Gazette* of 1986 at page 412.

- **3. Quota management areas**—The taking of squid in the quota management areas specified in the Schedule to this notice is hereby declared to be subject to the quota management system under Part IIA of the Act on and from the 1st day of November 1987.
- **4. Total allowable catches**—(1) Subject to this clause, the total allowable catch to be available in respect of squid for each quota management area is as stated in the final column of the Schedule to this notice alongside the reference to that area.
- (2) Where a particular method of fishing is specified in the Schedule to this notice alongside a total allowable catch for an area, that total allowable catch relates only to the taking of squid by that method.
- 5. Period to be used to determine provisional maximum individual transferable quotas—The period to be used under section 28E(1) of the Act in determining provisional maximum individual transferable quotas for squid is the fishing year commencing on the 1st day of October 1986.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice brings the taking of squid under the quota management system under Part IIA of the Fisheries Act 1983 on and from 1 November 1987.

Three quota management areas are established for squid:

- (a) Kermadec Area:
- (b) Southern Islands Area:
- (c) All other New Zealand fisheries waters (except part of the Auckland Fishery Management Area).

Total allowable catches of 10 greenweight tonnes and 32,333 greenweight tonnes are fixed for the Kermadec Area and Southern Islands Area respectively. Two separate total allowable catches are fixed for the other quota management area—57,705 greenweight tonnes for jigging and 30,962 greenweight tonnes for all methods.

The fishing year commencing 1 October 1986 is fixed as the period to be used in

determining provisional maximum individual transferable quotas for squid.
