

THE FISHERIES (GENERAL) REGULATIONS 1950, AMENDMENT NO. 22

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Fisheries (General) Regulations 1950, Amendment No. 22, and shall be read together with and deemed part of the Fisheries (General) Regulations 1950* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Size limit for the taking of scallops—The principal regulations are hereby amended by revoking regulation 106 (as substituted by regulation 3 of the Fisheries (General) Regulations 1950, Amendment No. 15), and substituting the following regulation:

"106. (1) No person shall take any scallop the shell of which, whether entire, chipped, or broken, is less than 100 mm in greatest diameter.

- "(2) No person shall have in his possession or sell, store, or process any scallop in the shell, or the shell of any scallop, which, whether entire, chipped, or broken, is less than 100 mm in greatest diameter."
- 3. Restrictions on processing scallops—Regulation 106A of the principal regulations (as inserted by regulation 3 of the Fisheries (General) Regulations 1950, Amendment No. 15) is hereby amended by adding the following subclauses:
 - "(3) No person shall land or begin the processing of any dead scallop.
- "(4) For the purposes of subclause (3) of this regulation, the act of shelling or shucking any scallop shall be deemed to be processing."

4. Restrictions on dredging for scallops in Golden Bay, Tasman Bay, and Marlborough Sounds—The principal regulations are hereby further amended by inserting, after regulation 106A (as inserted by regulation 3 of the Fisheries (General) Regulations 1950, Amendment No. 15), the following regulation—

"106AA. (I) No person shall dredge for scallops between sunset on any day and sunrise on the following day in the waters bounded by a line commencing at Farewell Spit, thence in a straight line to Cape Stephens, thence in a straight line to Cape Jackson, thence in a straight line to Cape Koamaru, thence in a straight line terminating at West

Head, Tory Channel.

"(2) For the purposes of subclause (1) of this regulation, the times of sunset and sunrise on any particular day shall be as specified for that day in the Nautical Almanac."

- 5. Close season for scallops—Regulation 106c of the principal regulations (as inserted by regulation 3 of the Fisheries (General) Regulations 1950, Amendment No. 15) is hereby amended by revoking subclause (2), and substituting the following subclause:
- "(2) For the purpose of this regulation the close season for scallops shall commence on the 15th day of February in each year and end with the 14th day of July in that year."
- 6. Metric amendments—The principal regulations are hereby further amended in the manner indicated in the Schedule to these regulations.
- **7. Revocations**—The following regulations are hereby consequentially revoked:
 - (a) Regulation 4 of the Fisheries (General) Regulations 1950, Amendment No. 10*:
 - (b) Regulation 4 (1) of the Fisheries (General) Regulations 1950, Amendment No. 18†.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Fisheries (General) Regulations 1950.

Regulation 2 provides that the minimum size of a scallop shell that may be taken or had in possession is 100 mm in greatest diameter, whether the shell is

Regulation 4 inserts a new regulation which prohibits dredging for scallops in certain defined waters between sunset on any one day and sunrise the following day.

Regulation 5 amends the period of the close season for scallops from 1 March—31 July in any year to 15 February—14 July in any year.

Regulation 6 makes metric amendments to the principal regulations.
