THE FISHERIES (GENERAL) REGULATIONS 1950,  
AMENDMENT NO. 25

ORDER IN COUNCIL

At the Government Buildings at Wellington this 27th day of June 1977

Present:

THE RIGHT HON. B. E. TALBOYS PRESIDING IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Fisheries (General) Regulations 1950, Amendment No. 25, and shall be read together with and deemed part of the Fisheries (General) Regulations 1950\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 30th day of June 1977.

**2. Use of Danish seine net by more than 1 vessel**—Regulation 69 (3) of the principal regulations (as inserted by regulation 5 of the Fisheries (General) Regulations 1950, Amendment No. 20, and amended by regulation 2 of the Fisheries (General) Regulations 1950, Amendment No. 24) is hereby further amended by omitting the words “30th day of June 1977”, and substituting the words “31st day of August 1977”.

**3. Prohibited waters for use of Danish seine net**—Regulation 72 (10) of the principal regulations (as substituted by regulation 3 of the Fisheries (General) Regulations 1950, Amendment No. 19, and amended by regulation 6 of the Fisheries (General) Regulations 1950

Amendment No. 20, and regulation 3 of the Fisheries (General) Regulations 1950, Amendment No. 24) is hereby further amended by omitting the words "30th day of June 1977", and substituting the words "31st day of August 1977".

**4. Revocation**—The Fisheries (General) Regulations 1950, Amendment No. 24, are hereby consequentially revoked.

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations amend the Fisheries (General) Regulations 1950. The effect is to extend, until 31 August 1977, the provisions relating to Danish seining by more than 1 vessel, and to Danish seining in the Hauraki Gulf.
