



**THE FISHERIES (GENERAL) REGULATIONS 1950,
AMENDMENT NO. 27**

ORDER IN COUNCIL

At the Government House at Wellington this 26th day of September 1977

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Fisheries (General) Regulations 1950, Amendment No. 27, and shall be read together with and deemed part of the Fisheries (General) Regulations 1950* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1977.

2. Size of mesh of net—Regulation 8 of the principal regulations is hereby amended by omitting the words “tanned, barked, or”.

3. Requirements for trawl nets—(1) Regulation 75 of the principal regulations (as amended by regulation 12 of the Fisheries (General) Regulations 1950, Amendment No. 26) is hereby further amended by revoking subclause (1), and substituting the following subclause:

“75. (1) No person shall use for fishing—

“(a) Any trawl net the size of the mesh of which (as ascertained in accordance with regulation 8 of these regulations) is in the cod-end less than 100 mm; or

“(b) Any trawl net that has in the cod-end more than one layer of mesh; or

“(c) Any trawl net that has in the cod-end liners or sleeves of any material whatsoever:

“Provided that nothing in this subclause shall be construed to prohibit the use of any chafer or chafing gear on the underside of any trawl net.”

(2) Regulation 76 of the principal regulations is hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Fisheries (General) Regulations 1950.

Regulation 2 deletes obsolete terms.

Regulation 3 amends the requirements for trawl nets.

The regulations come into force on 1 October 1977.
