

THE FISHERIES (GENERAL) REGULATIONS 1950, AMENDMENT NO. 89

ORDER IN COUNCIL

At the Government Buildings at Wellington this 8th day of August 1983

Present:

THE RIGHT HON. D. MACINTYRE PRESIDING IN COUNCIL PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Fisheries (General) Regulations 1950, Amendment No. 39, and shall be read together with and deemed part of the Fisheries (General) Regulations 1950* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.
- **2. Prohibition of use of trawl net**—Regulation 79 of the principal regulations (as substituted by regulation 8 of the Fisheries (General) Regulations 1950, Amendment No. 38) is hereby amended by omitting from subclause (5) the expression "registered length", and substituting the expression "overall length".
- **3. Prohibition on use of tines in Southern scallop fishery**—The principal regulations are hereby amended by inserting, after regulation

106c (as inserted by regulation 3 of the Fisheries (General) Regulations 1950, Amendment No. 15), the following regulation:

"106CA. (1) No person shall, for the purpose of taking scallops from the Southern scallop fishery, use any dredge which has tines attached to or protruding from the leading edge of the ground bar of that dredge.

"(2) For the purposes of this regulation, 'Southern scallop fishery' means

"(2) For the purposes of this regulation, 'Southern scallop fishery' means the scallop fisheries within New Zealand fisheries waters between Cape

Campbell and Kahurangi Point."

- **4. Restrictions on taking certain species**—Regulation 106Q of the principal regulations (as substituted by regulation 11 of the Fisheries (General) Regulations 1950, Amendment No. 38) is hereby amended by revoking subclause (4).
- **5. Domestic vessels in exclusive economic zone to report**—The principal regulations are hereby amended by substituting, for regulation 106zA (which was impliedly revoked by regulation 11 (3) (c) of the Fisheries (General) Regulations 1950, Amendment No. 38), the following regulation:

"106zA. (1) The master of every registered fishing boat fishing outside the limit of the territorial sea (as defined in the Territorial Sea and Exclusive Economic Zone Act 1977) in any part of the New Zealand Fisheries Management Area shall report the position of his boat and the quantity of each species of fish taken, in such form and to be received at such times, as the Director-General may require.

"(2) Failure to comply with the requirements of the Director-General under subclause (1) of this regulation shall constitute an offence by the owner and the master of the boat."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Fisheries (General) Regulations 1950.

Regulation 2 corrects a reference from "registered length" to "overall length" in relation to trawlers fishing in the area from Waipatiki Stream to Cape Kidnappers.

Regulation 3 prohibits the use of tines on scallop dredges in the Southern scallop fishery.

Regulation 4 removes the prohibition on taking orange roughy during August and September.

Regulation 5 is a drafting amendment which re-makes regulation 1062A of the principal regulations, which may have been inadvertently revoked when provisions relating to the imposition of quotas were revoked.
