PURSUANT to section 270 of the Fisheries Act 1996, His Excellency the Governor-General, on the recommendation of the Minister for Food, Fibre, Biosecurity and Border Control, and acting by and with the advice and consent of the Executive Council, makes the following order.

SCHEDULE

Amendments to Part A of Schedule of
Principal Order in Relation to Monthly
Levies on Quota Holders

1. Title and commencement—(1) This order may be cited as the Fisheries (Cost Recovery Levies) Amendment Order 1999, and is part of the Fisheries (Cost Recovery Levies) Order 1998* (“the principal order”).

(2) This order comes into force on 1 April 1999.

2. Monthly levies on quota holders—Part A of the Schedule of the principal order is amended by omitting from the Fisheries Management

Services component of that Part the items relating to the fishstocks that are specified in the first column of the Schedule of this order, and substituting the fishstocks and monthly levy amounts set out in the Schedule of this order.

3. Levies on non-ITQ species (skate)—Part B of the Schedule of the principal order is amended by omitting the item relating to SKA, and substituting the following item:

“SKA 0.00”.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order amends the Fisheries (Cost Recovery Levies) Order 1998 by correcting the figures for monthly levies on quota holders for certain fishstocks and for levies payable by non-ITQ fishers of skate.

The amendments to the monthly levies arise mainly as a result of corrections to the charges for quota forfeit to the Crown.

In addition, amendments to the various rock lobster fishstocks remove a policy advice cost incorrectly allocated to rock lobster, an amendment in relation to the northern scallop fishery removes the cost of a research project, and amendments to the southern scallop fishstock arise from correcting the tonnage on which the southern scallop levy is based.

The amendment in relation to skate (which results in a nil levy being payable from 1 April 1999 to compensate for over-recovery in the preceding 6 months) arises from a correction in the port price used to allocate costs to skate.
