ORDER

**1. Title and commencement**—(1) This order may be cited as the Fisheries (Cost Recovery Levies) Amendment Order (No. 2) 1999, and is

part of the Fisheries (Cost Recovery Levies) Order 1999\* (“the principal order”).

(2) This order comes into force on 1 October 1999.

**2. Conservation levies**—(1) Part A of the Schedule of the principal order is amended by adding the items set out in Schedule 1 of this order.

(2) Part B of the Schedule of the principal order is amended by adding the items set out in Schedule 2 of this order.

(3) Part C of the Schedule of the principal order is amended by adding the item set out in Schedule 3 of this order.

EXPLANATORY NOTE

*This note is not part of the order, but is intended to indicate its general effect.*

This order, which comes into force on 1 October 1999, amends the Fisheries (Cost Recovery Levies) Order 1999 by adding conservation levies to Parts A to C of the Schedule of the principal order. The amendment enables the Crown to recover, from the fishing industry, the industry's share of the costs of fisheries-related conservation services incurred by the Crown in the 1999/2000 financial year. The levies are recoverable over the fishing year beginning on 1 October 1999.
