ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 107G of the Fisheries Act 1983, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council and on the recommendation of the Minister of Fisheries, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Fisheries (Resource Rentals Variation) Order 1987.

(2) This order shall come into force on the 1st day of October 1987.

2. Variation of resource rentals—The Fisheries Act 1983 is hereby amended by revoking Schedule 1B (as inserted by section 13 (4) of the Fisheries Amendment Act 1986) and Schedule 1C (as inserted by section 28 (2) of that Act), and substituting the Schedules 1B and 1C set out in the Schedule to this order.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order varies the annual resource rentals payable to the Crown under the Fisheries Act 1983 in respect of fish taken during the fishing year commencing 1 October 1987. No change is made to the resource rentals payable in respect of the following:

- (a) Ling taken in the Sub-Antarctic area:
- (b) Red Cod taken in the South-East (Coast) area:
- (c) Stargazer taken in the South-East (Chatham Rise) area:
- (d) Oysters:
- (e) Scallops.

The other resource rentals for species previously named in Schedules 1B and 1C of the Act are increased by 20 percent or, in the case of those payable under the individual transferable quota system where the fisherman has the use of a foreign owned New Zealand fishing vessel, to amounts double those applying where the fisherman does not have the use of a foreign owned fishing vessel. A number of species not previously named in Schedule 1B are now named and have specific resource rentals.
