

# THE FIRE SAFETY AND EVACUATION OF BUILDINGS REGULATIONS 1992, AMENDMENT NO. 2

#### ORDER IN COUNCIL

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fire Service Act 1975, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Fire Safety and Evacuation of Buildings Regulations 1992, Amendment No. 2, and shall be read together with and deemed part of the Fire Safety and Evacuation of Buildings Regulations 1992\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.
- 2. Contents of draft evacuation scheme—(1) Regulation 14 (2) (i) (iv) of the principal regulations is hereby amended by inserting after the word "Identify", the words "the likely locations in the building of".

S.R. 1992/861 Amendment No. 1: S.R. 1993/428 (2) Regulation 14 (2) (i) of the principal regulations is hereby amended by revoking subparagraph (v), and substituting the following subparagraph:

"(v) Identify persons assigned to assist, in the event of an

evacuation,—

"(A) The persons whose likely locations in the building are known and whose locations are on the assistance

register; and

- "(B) Any persons with disabilities whose locations are not on the assistance register because they are visitors to the building at the time of the evacuation or otherwise; and".
- 3. Grounds for determining that a building's automatic sprinkler system is inadequate, etc.—Regulation 15 (1) (a) (iii) of the principal regulations is hereby amended—

(a) By omitting the words "owner of", and substituting the words "owner or":

(b) By omitting the words "sections 44 and 45", and substituting the words "section 44 or section 45".

#### **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 of these regulations amends the provision relating to the contents of draft evacuation schemes to require the likely locations of persons with disabilities to be identified instead of the names of such persons.

Regulation 3 of these regulations corrects 2 errors in the Fire Safety and Evacuation of Buildings Regulations 1992.
