

THE FIRE SERVICE (SERVICE ORGANISATION MEMBERSHIP) REGULATIONS 1985

ORDER IN COUNCIL

At the Government House at Wellington this 24th day of June 1985

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 92 of the Fire Service Act 1975, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Fire Service (Service Organisation Membership) Regulations 1985.
 - (2) These regulations shall come into force on the 1st day of July 1985.
- 2. Forms—(1) Form 1 in the Schedule to these regulations shall apply for the purposes of subclause (1) of the rule relating to restoration ballots and initial ballots (which is set out in section 83B of the Fire Service Act 1975) in the place of form 1 in Schedule 1B to the Industrial Relations Act 1973.
- (2) Form 2 in the Schedule to these regulations shall apply for the purposes of subclause (1) of the rule relating to the form of application for special vote (which is set out in section 83B of the Fire Service Act 1975) in the place of form 2 in Schedule 1B to the Industrial Relations Act 1973.

(3) Form 3 in the Schedule to these regulations shall apply for the purposes of subsection (1) of section 83H of the Fire Service Act 1975 in the place of form 3 in Schedule 1B to the Industrial Relations Act 1973.

(4) Form 4 in the Schedule to these regulations shall apply for the purposes of subsection (2) of section 831 of the Fire Service Act 1975 in the place of form 4 in Schedule 1B to the Industrial Relations Act 1973.

(5) Form 5 in the Schedule to these regulations shall apply for the purposes of subsection (4) of section 831 of the Fire Service Act 1975 in the place of form 5 in Schedule 1B to the Industrial Relations Act 1973.

(6) Form 6 in the Schedule to these regulations shall apply for the purposes of subsection (2) of section 83L of the Fire Service Act 1975 in the place of form 6 in Schedule 1B to the Industrial Relations Act 1973.

- Where there is to be more than one special meeting and the application relates to a special meeting to be held during your normal working hours, the application will not be valid if any other special meeting is to be held during your normal working hours at a place that is nearer, by the most practicable route, to your usual place of work.
- Where there is to be more than one special meeting and the application relates to a special meeting held outside your normal working hours, the application shall not be valid if any other special meeting is to be held outside your normal working hours at a place that is nearer, by the most practicable route, to your place of residence.

Fire Service (Service Organisation Membership) Regulations 1985

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 July 1985, prescribe forms that are to be used, for the purposes of the Fire Service Act 1975, in the place of forms 1 to 6 in Schedule 1B to the Industrial Relations Act 1973.

All the forms prescribed by these regulations relate to the procedures by which a service organisation determines whether a service organisation membership clause is to be included in each of the determinations of the Fire Service Commission by which members of the service organisation are bound from time to time.
