PURSUANT to sections 8B and 141 of the Gaming and Lotteries Act 1977, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Gaming and Lotteries (Licence Fees) Regulations 1992.

(2) These regulations shall come into force on the day after the date of their notification in the Gazette.

2. Interpretation—In these regulations, "the Act" means the Gaming and Lotteries Act 1977.

3. Licence fees—There shall be paid to the Secretary for Internal Affairs, for each matter specified in the Schedule to these regulations, the fee specified for it in that Schedule.

4. Goods and services tax included—The fees prescribed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

5. Revocation-The Gaming Machines (Licence Fees) Regulations 1991* are hereby consequentially revoked.

EXPLANATORY NOTE This note is not part of the regulations, but is intended to indicate their general effect.

These regulations prescribe certain licence fees payable under the Gaming and Lotteries Act 1977.

The licence fees payable under the Act in respect of housie and licensed promoters are prescribed by other regulations.

These regulations replace the Gaming Machines (Licence Fees) Regulations 1991. The licence fees in respect of gaming machines are the same as the fees prescribed by those regulations.

These regulations also introduce new licence fees of \$85 in respect of-

(a) Other instant games and games of chance that are not conducted by means of a gaming machine:

(b) Prize competitions:

(c) Lotteries.

All of the fees are inclusive of goods and services tax.
