PURSUANT to section 241 of the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the General Harbour (Ship, Cargo, and Dock Safety) Regulations 1968, Amendment No. 7, and shall be read together with and deemed part of the General Harbour (Ship, Cargo, and Dock Safety) Regulations 1968* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of May 1982.

- 2. Design approval fees—Regulation 16A (4) of the principal regulations (as inserted by regulation 5 of the General Harbour (Ship, Cargo, and Dock Safety) Regulations 1968, Amendment No. 1) is hereby amended by omitting the word "testing", and substituting the words "design approval, testing,".
- **3. Lifting of stretchers**—The principal regulations are hereby amended by revoking regulation 122, and substituting the following regulation:

"122. The stretcher shall be of a suitable standard and provided with slings to enable it to be safely lifted from the ship's hold by the ship's

lifting gear or the shore lifting gear."

- **4. Design approval, testing, and inspection fees**—The principal regulations are hereby amended by revoking the Third Schedule (as substituted by regulation 2 of the General Harbour (Ship, Cargo, and Dock Safety) Regulations 1968, Amendment No. 6), and substituting the new Third Schedule set out in the Schedule to these regulations.
- **5. Revocation**—The General Harbour (Ship, Cargo, and Dock Safety) Regulations 1968, Amendment No. 6 are hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 May 1982, substitute a new scale of testing, inspection, and design approval fees for cargo containers and mechanical cargo handling equipment.

Regulation 3 revokes a regulation requiring stretchers to be of a specific New Zealand standard, and substitutes a requirement that they be of a suitable standard.
