THE GOVERNMENT RAILWAYS CLASSIFICATION AND PAY **REGULATIONS 1942, AMENDMENT NO. 4**

ORDER IN COUNCIL

At the Government House at Wellington, this 4th day of September, 1946

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Government Railways Act, 1926, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Government Railways Classification and Pay Regulations 1942, Amendment No. 4, and shall be read together with and deemed part of the Government Railways Classification and Pay Regulations 1942* (hereinafter referred to as the principal regulations).

2. These regulations shall be deemed to have come into force on the 1st day of April, 1946.

3. The principal regulations are amended by revoking Regulation 15, and substituting the following regulation :---

"15. To every member classified in Classes 1 and 2 of Subdivision I of the First Division there shall be paid salary at such rate as may be provided for in the annual estimates of the Department and appropriated by Parliament."

4. The principal regulations are further amended by revoking Regulation 16, and substituting the following regulation :---

"16. Subject to the provisions of Regulations 7 and 8 hereof, there shall be paid to every member and probationer for the time being classified in Class 3 of Subdivision I or in Subdivision II of the First Division salary at the respective rate attached to the grade (and subgrade, if any) in the said First Schedule in which he is classified."
