#### ORDER IN COUNCIL

At the Government House at Wellington this 5th day of June 1979

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL PURSUANT to the Government Railways Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

### ORDER

- 1. Title and commencement—(1) This Order may be cited as the Government Railways (Fees for Documents) Order 1979.
- (2) This order shall come into force on the day after the date of its notification in the *Gazette*.
- 2. Fees for documents—The fees which the Minister of Railways may charge for the preparation of the documents specified in section 57 of the Government Railways Act 1949 shall be those prescribed in the Schedule to this order.
- 3. Revocations—The Government Railways (Fees for Documents) Order 1967 and the Government Railways (Fees for Documents) Order 1967, Amendment No. 1 are hereby revoked.
