PURSUANT to the Government Railways Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Government Railways (Fees for Documents) Order 1979, Amendment No. 1, and shall be read together with and deemed part of the Government Railways (Fees for Documents) Order 1979* (hereinafter referred to as the principal order).

(2) This order shall come into force on the 14th day after the date of its notification in the *Gazette*.

2. Fees for documents—The Schedule to the principal order is hereby amended—

- (a) By revoking item 5, and substituting the new item 5 set out in Part I of the Schedule to this order:
- (b) By revoking item 10, and substituting the new item 10 set out in Part II of the Schedule to this order:
- (c) By adding the new item 16 set out in Part III of the Schedule to this order.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order amends the Government Railways (Fees for Documents) Order 1979. It provides a revised scale of fees for a deed or memorandum of lease, and for an agreement or memorandum altering the terms of any lease, easement, or grant. It also provides for a set fee on agreement or memorandum altering the terms of any siding agreement.
