ORDER 1967**

ORDER IN COUNCIL

At the Government House at Wellington this 1st day of November 1967

Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to the Government Railways Act 1949, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Government Railways (Fees for Documents) Order 1967.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. The fees which the Minister of Railways may charge for the preparation of the documents specified in section 57 of the Government Railways Act 1949 shall be those prescribed in the Schedule to this order.

3. The Government Railways (Fees for Documents) Order 1951* is hereby revoked.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order revokes the Government Railways (Fees for Documents) Order 1951, and replaces it with a new order authorising the Minister of Railways to charge increased fees for the preparation of those documents specified in section 57 of the Government Railways Act 1949.
