# THE GOVERNMENT SERVICE BOARDS ELECTIONS EMERGENCY REGULATIONS 1943

## C. L. N. NEWALL, Governor-General. ORDER IN COUNCIL.

At the Government House at Wellington, this 17th day of February, 1943.

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

### REGULATIONS.

1. These regulations may be cited as the Government Service Boards Elections Emergency Regulations 1943.

### APPLICATION OF THESE REGULATIONS.

- 2. These regulations apply with respect to the election of the elective members of the following Boards, namely:—
  - (a) The Board of Appeal constituted in accordance with section 13 of the Public Service Amendment Act, 1927:
  - (b) The Post and Telegraph Promotion Board constituted in accordance with section 234 of the Post and Telegraph Act, 1928:
  - (c) The Post and Telegraph Appeal Board constituted in accordance with section 236 of the Post and Telegraph Act, 1928.

POSTPONEMENT OF ELECTIONS OF ELECTIVE MEMBERS OF THE SEVERAL BOARDS TO WHICH THESE REGULATIONS APPLY.

- 3. (1) Notwithstanding anything to the contrary in any Act or regulations, the following provisions shall apply with respect to the next ordinary election of the elective members of the several Boards referred to in the last preceding clause:—
  - (a) There shall be no ordinary election of elective members of the Public Service Board of Appeal in the month of May, 1943, and the next ordinary election to be held under paragraph (a) of section 14 of the Public Service Amendment Act, 1927, shall be held in the month of May, 1944:

- (b) There shall be no ordinary election of an elective member of the Post and Telegraph Board in the month of February, 1943, and the next election to be held under clause 41 of the regulations relating to the said Board (being regulations made under the Post and Telegraph Act, 1918, on the 14th day of December, 1925) shall be held on the third Wednesday in February, 1944:
- (c) There shall be no ordinary election of elective members of the Post and Telegraph Appeal Board in the month of June, 1943, and the next election to be held under clause 83 of the regulations relating to the said Board (being regulations made under the Post and Telegraph Act, 1918, on the 14th day of December, 1925) shall be held on the fourth Wednesday in June, 1944.
- (2) The term of office of the several elective members of the said Boards in office on the commencement of these regulations is hereby extended until their successors come into office in accordance with these regulations.
