## THE GRAPE VINE DISEASES REGULATIONS 1952, AMENDMENT NO. 1

At the Government House at Wellington this 11th day of November 1968

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Orchard and Garden Diseases Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. (1) These regulations may be cited as the Grape Vine Diseases Regulations 1952, Amendment No. 1, and shall be read together with and deemed part of the Grape Vine Diseases Regulations 1952\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Regulation 2 of the principal regulations is hereby amended by revoking the definition of "prescribed area", and substituting the following definition:
  - "'Prescribed area' means all that area of land comprising—
    - "(a) The Counties of Tauranga, Matamata, Waipa, and Raglan together with all that portion of the North Island lying to the north of those counties; and
      - "(b) The County of Hawke's Bay:".
- 3. The principal regulations are hereby further amended by revoking regulation 3, and substituting the following regulation:
- "3. Every person commits an offence against the Orchard and Garden Diseases Act 1928 and shall be liable accordingly on summary conviction to a fine not exceeding forty dollars who, directly or indirectly, whether by himself, his servant or agent—

- "(a) Removes or causes to be removed, or attempts to remove or cause to be removed, any vine or insect from the prescribed area:
- "(b) Takes or causes to be taken, or attempts to take or cause to be taken, into the County of Hawke's Bay, any vine or insect from any place in the Counties of Tauranga, Matamata, Waipa, and Raglan, or from that portion of the North Island lying to the north of those counties:

"Provided that any vine may be removed from the prescribed area if it is accompanied by a certificate signed by an inspector that it has been treated as directed by him and to his satisfaction:

"Provided also that any Inspector may remove, or cause to be removed, any vine or insect from the prescribed area for the purpose of the identification of disease or suspected disease."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the definition of the term "prescribed area", to include the County of Hawke's Bay, and make it an offence to take any grape vine or vine louse into this county, from any other part of the prescribed area.
