THE HONEY (1942-43 SEASON) EMERGENCY REGULATIONS 1942, AMENDMENT NO. 1

THE RIGHT HON, P. FRASER PRESIDING IN COUNCIL

Pursuant to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Honey (1942–43 Season) Emergency Regulations 1942, Amendment No. 1, and shall be read together with and deemed part of the Honey (1942–43 Season) Emergency Regulations 1942* (hereinafter referred to as the principal regulations).
- 2. Clause 7 of the principal regulations is hereby revoked as from the making of the said regulations, and the following clause is and shall be deemed to have been substituted therefor:—
 - "7. (1) For the purposes of this clause,—
 - "'' Bulk container' has the same meaning as in the Honey Marketing Regulations 1938†:
 - "'Graded honey' means honey that has been graded in accordance with the practice of the Department of Agriculture; and 'ungraded honey' means honey that has not been so graded.
- "(2) The price to be paid by the Department for any honey acquired by it under these regulations in bulk containers shall be—

"Graded Honey—

- "(a) For honey to which 100 grading-points have been allotted: 7d. per pound.
- "(b) For honey to which less than 100 grading-points have been allotted: A price bearing to 7d. per pound the same proportion as the grading-points allotted to that honey bear to 100 grading-points.

" Ungraded Honey-

- "(a) For best-quality honey (as determined by the Department): 7d. per pound.
- "(b) For other honey: Such lower price than 7d. per pound as the Department may determine, having regard to the flavour, colour, and condition of the honey.
- "(3) The price to be paid by the Department for honey packed in retail containers shall be the maximum price that (in accordance with any Price Order for the time being in force under the Control of Prices Emergency Regulations 1939*) may be charged by a packer to a wholesaler, reduced by a discount of $12\frac{1}{2}$ per cent. or such less rate of discount as the Department may fix.
- "(4) The prices fixed in accordance with the foregoing provisions of this clause are fixed as for delivery to the Department at such depots or other places as the Department may determine:
- "Provided that where delivery to the Department is at a place more than 120 miles distant from the apiary where the honey was produced, all transport charges for any distance in excess of 120 miles shall be borne by the Department."
