THE HEARING AIDS NOTICE 1957

PURSUANT to regulation 4 of the Social Security (Hospital Benefits for Outpatients) Regulations 1947, the Minister of Health hereby gives the following notice.

NOTICE

1. This notice may be cited as the Hearing Aids Notice 1957.
2. In this notice, unless the context otherwise requires,—

“Approved speaking tube” means a speaking tube of a type approved in writing for the purposes of this notice by the Director-General of Health;

“Hearing aid” means an approved speaking tube, or an electrical hearing aid approved under clause 7 of this notice.
3. The supply of hearing aids to outpatients of public hospitals is hereby approved, subject to the following conditions:
 - (a) The supply of the aid is recommended by an otologist employed or engaged by the Hospital Board; and
 - (b) The patient possesses a hearing loss of at least 35 decibels in the better ear, over the significant frequencies of speech, or such other loss of a lesser degree as in the opinion of the otologist renders the use of an aid necessary; and
 - (c) The patient’s hearing loss is such that in the opinion of the otologist it is capable of correction or marked improvement by the use of the type of hearing aid supplied or approved for the purpose of the benefits; and
 - (d) The patient has not previously obtained a benefit in respect of a hearing aid under the above-mentioned regulations during the five years immediately preceding the date of his application, and is not already in possession of a hearing aid obtained under the provisions of the above-mentioned regulations that is, in the opinion of an otologist employed or engaged by the Board, still satisfactory and serviceable or capable of satisfactory repair; and
 - (e) In the case of an approved speaking tube, such a tube is, in the opinion of the otologist, likely to be a more satisfactory hearing aid for the patient than an electrical hearing aid.
4. Where an outpatient of a public hospital is entitled to a hearing aid under clause 3 of this notice but does not wish to avail himself of the hearing aid issued free of charge by the Hospital Board, the Board may pay on behalf of the patient a sum not exceeding £13 towards the purchase of an approved electrical hearing aid or a sum not exceeding £3 towards the purchase of an approved speaking tube.

5. Where an outpatient of a public hospital has received a benefit in respect of a hearing aid during the immediately preceding period of five years, the Hospital Board may pay on behalf of the patient towards the cost of replacing the hearing aid a sum that equals half the cost of the replacement hearing aid but does not in any case exceed £6 10s. in the case of an approved electrical hearing aid or £1 10s. in the case of an approved speaking tube. No benefit may be granted under this clause unless—

- (a) In the opinion of an otologist employed or engaged by the Board the replacement hearing aid will benefit the hearing of the patient to an extent that the aid already issued does not; and
- (b) The patient is otherwise eligible to receive a hearing aid.

6. Where an outpatient of a public hospital has not received a benefit in respect of a hearing aid during the immediately preceding period of five years but is in possession of a hearing aid obtained under the provisions of the above-mentioned regulations that is, in the opinion of an otologist employed or engaged by a Hospital Board, still satisfactory and serviceable or capable of satisfactory repair, the Hospital Board may pay on behalf of the patient towards the cost of replacing the hearing aid a sum that equals half the cost of the replacement hearing aid but does not in any case exceed £6 10s. in the case of an approved electrical hearing aid or £1 10s. in the case of an approved speaking tube. No benefit may be granted under this clause unless the patient is otherwise eligible to receive a hearing aid.

7. The types of electrical hearing aids specified in the Schedule to this notice are hereby approved for the purposes of this notice: Provided that this clause shall not apply—

- (a) To any existing model of any such hearing aid unless that model was approved, under the Hearing Aids Notice 1955, before the commencement of this notice, or is approved in writing for the purposes of this notice by the Director-General of Health:
- (b) To any new model of any such hearing aid issued after the commencement of this notice, unless that new model is approved in writing for the purposes of this notice by the Director-General of Health.

8. (1) The Hearing Aids Notice 1955,* the Hearing Aids Notice 1955, Amendment No. 1†, the Hearing Aids Notice 1955, Amendment No. 2‡, and the Hearing Aids Notice 1955, Amendment No. 3§, are hereby revoked.

(2) Without limiting the provisions of the Acts Interpretation Act 1924, it is hereby declared that the revocation of the said notices shall not affect any document made or any thing whatsoever done thereunder or under any corresponding former notice, and every such document or thing, so far as it is subsisting or in force at the time of the revocation and could have been made or done under this notice, shall continue and have effect as if it had been made or done under the corresponding provision of this notice and as if that provision had been in force when the document was made or the thing was done.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice consolidates the Hearing Aids Notice 1955 and its amendments, providing for the supply of approved hearing aids to hospital outpatients.

This notice also increases from £1 to £1 10s. the maximum amount that may be paid towards the replacement of any approved speaking tube (clause 6), and extends the list of approved electrical hearing aids to include Akumed hearing aids.
