ORDER IN COUNCIL

At the Government House at Wellington this 1st day of September 1965

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to the Harbours Act 1950, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. (1) This order may be cited as the Harbour Boards Representation Order 1959, Amendment No. 3, and shall be read together with and deemed part of the Harbour Boards Representation Order 1959* (hereinafter referred to as the principal order).
- (2) This order shall come into force on the 3rd day of September 1965.
- 2. (1) The First Schedule to the Harbours Act 1950 (as substituted by section 20 (1) of the Harbours Amendment Act 1959) is hereby amended—
 - (a) By omitting from so much of the second column as relates to the Auckland Harbour Board the words "County of Manukau and of the Boroughs of Manurewa, Papakura", and substituting the words "City of Manukau and of the Boroughs of Papakura":

(b) By omitting from so much of the second column as relates to the Lyttelton Harbour Board the word "Springs" and also the word "Selwyn":

(c) By omitting from so much of the second column as relates to the Otago Harbour Board the words "Borough of St. Kilda", and substituting the words "Boroughs of St. Kilda and Green Island":

- (d) By omitting from so much of the second column as relates to the Otago Harbour Board the words "Boroughs of Port Chalmers and West Harbour", and substituting the words "Borough of Port Chalmers":
- (e) By omitting from so much of the second column as relates to the Otago Harbour Board the words "Boroughs of Green Island and Mosgiel", and substituting the words "Borough of Mosgiel":
- (f) By omitting from so much of the second column as relates to the Southland Harbour Board the words "Town Districts of Lumsden and Wyndham", and substituting the words "Town District of Wyndham":
- (g) By omitting from so much of the second column as relates to the Wellington Harbour Board the word "Mauriceville".
- (2) Subject to the provisions of sections 30 and 31 of the Harbours Act 1950, the representatives of constituent districts or combined districts holding office as members of Harbour Boards at the commencement of this order shall, unless they cease to hold office pursuant to the provisions of any other enactment, continue to hold office until their successors elected at the next triennial election of members of Harbour Boards come into office.
- 3. (1) The principal order is hereby further amended by revoking the First Schedule, and substituting the First Schedule set out in the Schedule to this order.
- (2) The Harbour Boards Representation Order 1959, Amendment No. 1, is hereby revoked.
- (3) The Harbour Boards Representation Order 1959, Amendment No. 2, is hereby amended by revoking clause 3.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

(a) Alters the constitution of the Otago Harbour Board by excluding the Borough of Green Island from the combined district of the County of Taieri and the Boroughs of Green Island and Mosgiel, and constitutes a new combined district comprising the boroughs of St. Kilda and Green Island:

(b) Makes such changes in the First Schedule to the Harbours Act 1950 (setting out the constitution of the Harbour Boards) as are necessary as a result of the constitution of the City of Manukau (comprising the former County of Manukau and Borough of Manurewa) and of the abolition of the Counties of Springs, Selwyn, and Mauriceville, the Borough of West Harbour, and the Town District of Lumsden:

(c) Replaces the existing First Schedule to the principal order (relating to the principal local authorities to conduct the election of members of Boards in combined districts), with such changes as are necessary as a result of the changes mentioned above and as a result of the constitution of

of the changes mentioned above and as a result of the constitution of the Northland Harbour Board and the Taranaki Harbours Board.
