PURSUANT to the Hospitals Act 1957, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Hospital Boards Representation Order 1974.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*:

Provided that, in respect of the Wellington Hospital District, and the South Canterbury Hospital District, this order shall come into force on the 2nd day of September 1974.

(3) Notwithstanding anything in clause 1 (2) of the Bay of Plenty Hospital District Order 1974*, the provisions of the Local Elections and Polis Act 1966 shall apply in respect of the election of members of the Bay of Plenty Hospital Board, constituted under this order, to such extent as may be necessary to enable that election to be held on the 12th day of October 1974.

2. Representation on Boards—The numbers of members to be elected to the Boards of the hospital districts named in the first column of the Schedule to this order as the representative or representatives of the constituent districts (including combined districts) named in the second column shall be the numbers specified in the third column.

3. Combined Districts—The constituent districts, the names of which are set out in the second column of the Schedule to this order and therein bracketed together, are hereby combined into combined districts.

4. Principal local authorities for conduct of elections—The local authorities of the districts which are distinguished in the second column of the Schedule to this order by the letter "(P)" are hereby selected and appointed to be the principal local authorities of the combined districts in which the districts of those local authorities are included for the purpose of the conduct of elections within those combined districts.

5. Board members to continue in office pending successors' taking office—Subject to the provisions of sections 34 and 35 of the Hospitals Act 1957, and to the provisions of the Bay of Plenty Hospital District Order 1974*, the representatives of constituent districts and combined districts holding office as members of Hospital Boards on the date of the making of this order shall continue to hold office until the members elected at the next triennial election of members of Hospital Boards come into office.

6. Revocation—The Hospital Boards Representation Order 1971[†] is hereby revoked.
