PURSUANT to the Hospitals Act 1957, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- **1. Title and commencement**—(1) This order may be cited as the Hospital Boards Representation Order 1977.
- (2) This order shall come into force on the day after the date of its notification in the Gazette.
- 2. Representation on Boards—The numbers of members to be elected to the Boards of the hospital districts named in the first column of the Schedule to this order as the representative or representatives of the constituent districts (including combined districts) named in the second column shall be the numbers specified in the third column.
- 3. Combined Districts—The constituent districts, the names of which are set out in the second column of the Schedule to this order and therein bracketed together, are hereby combined into combined districts.
- 4. Principal local authorities for conduct of elections—The local authorities of the districts which are distinguished in the second column of the Schedule to this order by the letter "(P)" are hereby selected and appointed to be the principal local authorities of the combined districts in which the districts of those local authorities are included for the purpose of the conduct of elections within those combined districts.
- 5. Continuance in office of members—Subject to sections 34 and 35 of the Hospitals Act 1957, the representatives of constituent districts and combined districts holding office as members of Hospital Boards on the date of the making of this order shall continue to hold office until the members elected at the next triennial election of members of Hospital Boards come into office.
- **6. Revocation**—The Hospital Boards Representation Order 1974* is hereby revoked.
