PURSUANT to sections 19(1) and 30 of the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

# ORDER

1. Title and commencement-(1) This order may be cited as the Harbour Boards Representation Order 1986.

(2) This order shall come into force on the day after the date of its notification in the Gazette.

#### ANALYSIS

- 2. Interpretation—In this order—
- (a) References to the First Schedule to the Harbours Act 1950 are references to that Schedule as substituted by section 11 (1) of the Harbours Amendment Act (No. 2) 1971:
- (b) "The 1977 Order" means the Harbour Boards Representation Order 1977\*:
- (c) "The 1980 Order" means the Harbour Boards Representation Order 1980<sup>†</sup>:
- (d) "The 1983 Order" means the Harbour Boards Representation Order 1983<sup>‡</sup>.

**3.** Auckland Harbour Board—(1) The representation on the Auckland Harbour Board of the Borough of Mount Wellington is hereby cancelled, and replaced by representation of the Borough of Tamaki.

(2) The representation on the Auckland Harbour Board of the Borough of Otahuhu is hereby cancelled.

(3) The First Schedule to the Harbours Act 1950 (as amended by clause 3 of the 1977 Order and clause 3 of the 1980 Order) is hereby amended—

- (a) By omitting from that part of the second column that relates to the Auckland Harbour Board the words "Mount Wellington", and substituting the word "Tamaki":
- (b) By omitting from that same part the words "Boroughs of Otahuhu and Howick", and substituting the words "Borough of Howick".

**4. Gisborne Harbour Board**—(1) The representation on the Gisborne Harbour Board of part of the County of Wairoa is hereby cancelled, and replaced by representation of part of the District of Wairoa.

(2) The First Schedule to the Harbours Act 1950 is hereby amended by omitting from that part of the second column that relates to the Gisborne Harbour Board the words "Counties of Cook and Wairoa", and substituting the words "County of Cook and of the District of Wairoa".

**5. Hawke's Bay Harbour Board**—(1) The representation on the Hawke's Bay Harbour Board of the Borough of Wairoa and part of the County of Wairoa is hereby cancelled, and replaced by representation of part of the District of Wairoa.

(2) The First Schedule to the Harbours Act 1950 (as amended by section 7 (1) of the Harbours Amendment Act 1983) is hereby amended by omitting from that part of the second column that relates to the Hawke's Bay Harbour Board the words "Wairoa Borough and the electors of Wairoa County", and substituting the words "District of Wairoa".

**6. Lyttelton Harbour Board**—(1) The representation on the Lyttelton Harbour Board of the Borough of Rangiora is hereby cancelled.

(2) The First Schedule to the Harbours Act 1950 (as amended by clause 6 of the 1977 Order, clause 6 of the 1980 Order, and clause 3 of the 1983 Order) is hereby amended by omitting from that part of the second column that relates to the Lyttelton Harbour Board the words "Boroughs of Kaiapoi and Rangiora", and substituting the words "Borough of Kaiapoi".

Marlborough Harbour Board—(1) The representation on the Marlborough Harbour Board of the Kenepuru, Croisilles-French Pass, and Pelorus Ridings of Marlborough County is hereby cancelled, and replaced by representation of the Pelorus-Kenepuru and Pelorus-French Pass Ridings of that county.

(2) The First Schedule to the Harbours Act 1950 (as amended by clause 7 of the 1977 Order) is hereby amended by omitting from that part of the second column that relates to the Marlborough Harbour Board the words "Kenepuru and Croisilles-French Pass Ridings of the said county, 1 by the electors of the Pelorus Riding", and substituting the words "Pelorus-Kenepuru Riding of the said county; 1 by the electors of the Pelorus-French Pass Riding".

**8. Otago Harbour Board**—(1) The representation on the Otago Harbour Board of the County of Bruce and the Boroughs of Milton and Kaitangata is hereby cancelled, and replaced by representation of the District of Bruce.

(2) The First Schedule to the Harbours Act 1950 (as amended by clause 8 of the 1977 Order, clause 8 of the 1980 Order, and clause 4 of the 1983 Order) is hereby amended by omitting from that part of the second column that relates to the Otago Harbour Board the words "County of Bruce and of the Boroughs of Milton and Kaitangata", and substituting the words "District of Bruce".

**9. Southland Harbour Board**—(1) The County of Stewart Island shall be represented on the Southland Harbour Board.

(2) The representation on the Southland Harbour Board of the County of Lake and the Borough of Queenstown is hereby cancelled, and replaced by representation of the District of Queenstown-Lakes.

(3) The First Schedule to the Harbours Act 1950 (as amended by clause 9 (1) of the 1980 Order and clause 5 of the 1983 Order) is hereby amended by omitting that part of the second column that relates to the Southland Harbour Board, and substituting the following:

"Four by the electors of the City of Invercargill; 1 by the electors of the Borough of Bluff and of the County of Stewart Island; 1 by the electors of the Boroughs of Gore and Mataura; 3 by the electors of the County of Southland and of the Borough of Winton; 2 by the electors of the County of Wallace; and 1 by the electors of the District of Queenstown-Lakes and of the Borough of Arrowtown."

10. Taranaki Harbours Board—(1) The representation on the Taranaki Harbours Board of the County of Taranaki and the Borough of Waitara is hereby cancelled, and replaced by representation of the District of North Taranaki.

(2) The representation on that Board of the County of Inglewood and the Borough of Inglewood is hereby cancelled, and replaced by representation of the District of Inglewood.

(3) The representation on that Board of the County of Eltham and the Borough of Eltham is hereby cancelled, and replaced by representation of the District of Eltham.

(4) The representation on that Board of the Borough of Patea and part of the County of Patea is hereby cancelled, and replaced by representation of part of the District of Patea. (5) The First Schedule to the Harbours Act 1950 (as amended by clause 9 of the 1977 Order and clause 10 of the 1980 Order) is hereby amended by omitting that part of the second column that relates to the Taranaki Harbours Board, and substituting the following:

"Four by the electors of the City of New Plymouth; 2 by the electors of the District of North Taranaki; 1 by the electors of the District of Inglewood; 1 by the electors of the County of Egmont; 1 by the electors of the District of Eltham; 1 by the electors of the County of Stratford; 1 by the electors of the Borough of Stratford; 1 by the electors of the County of Clifton and of the parts of the County of Taumarunui and of the District of Waitomo and of the Borough of Taumarunui that are within the Taranaki Harbours District; 1 by the electors of the part of the District of Patea that is within the Taranaki Harbours District; 2 by the electors of the District of Hawera; and 1 by the electors of the County of Waimate West and of the Town District of Manaia."

**11. Wanganui Harbour Board**—(1) The representation on the Wanganui Harbour Board of the Town District of Waverley and part of the County of Patea is hereby cancelled, and replaced by representation of part of the District of Patea.

(2) The First Schedule to the Harbours Act 1950 is hereby amended by omitting from that part of the second column that relates to the Wanganui Harbour Board the words "Town District of Waverley and those of the electors of the County of Patea", and substituting the words "District of Patea".

12. Continuance in office—Subject to sections 30, 31, and 31A of the Harbours Act 1950, the representatives of constituent or combined districts holding office at the commencement of this order as members of any Harbour Board specified in any of clauses 3 to 11 of this order shall, unless they cease to hold office pursuant to any Order in Council made under section 36 of the Local Government Act 1974 or pursuant to any other enactment, continue to hold office until their successors elected at the next triennial election of members of Harbour Boards come into office.

13. Principal local authorities for combined districts—Each local authority named in the third column of the Schedule to this order is hereby selected and appointed to be the principal local authority for the purposes of the election of the member or members of the Harbour Board who are to be elected by the electors of the combined district specified in the second column opposite the name of the local authority.

14. Revocations—(1) Clause 9 of the Harbour Boards Representation Order 1977\* is hereby revoked.

(2) Clauses 9(1) and 10 of the Harbour Boards Representation Order 1980<sup>+</sup> are hereby revoked.

(3) Clauses 5, 7, and 8 of, and the Schedule to, the Harbour Boards Representation Order 1983<sup>‡</sup> are hereby revoked.

### EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order makes various amendments to the First Schedule to the Harbours Act 1950 which sets out the persons eligible to elect the members of harbour boards. The order also specifies the principal local authorities for those situations where the electors of all or part of different districts are to elect the same member or members.

Clause 3 relates to the Auckland Harbour Board and follows the amalgamation of the Boroughs of Mount Wellington and Otahuhu into the Borough of Tamaki.

*Clause 4* relates to the Gisborne Harbour Board and follows the amalgamation of Wairoa County and the Wairoa Borough into Wairoa District.

*Clause 5* relates to the Hawke's Bay Harbour Board and follows the amalgamation of Wairoa County and Wairoa Borough into Wairoa District.

Clause 6 relates to the Lyttelton Harbour Board and follows the amalgamation of Rangiora District and Rangiora Borough into Rangiora District.

Clause 7 relates to the Marlborough Harbour Board and results from a reduction in the number of ridings from 7 to 6.

Clause 8 relates to the Otago Harbour Board and results from the amalgamation of Bruce County, Milton Borough, and Kaitangata Borough into Bruce District.

Clause 9 relates to the Southland Harbour Board and follows the abolition of the Half-moon and Horseshoe Bays Harbour Board. It further results from the amalgamation of Lake County and Queenstown Borough into Queenstown-Lakes District.

*Clause 10* relates to the Taranaki Harbours Board and results from the amalgamation of the Taranaki County and Waitara Borough into the District of North Taranaki; the amalgamation of Eltham County and Eltham Borough into Eltham District; the amalgamation of Inglewood County and Inglewood Borough into Inglewood District; and the amalgamation of Patea County, Patea Borough, and Waverley Town District into Patea District.

Clause 11 relates to the Wanganui Harbour Board and results from the amalgamation of Patea County, Patea Borough, and Waverley Town District into Patea District.

Clause 12 provides for the continuation in office of existing elected members until the next triennial election.

*Clause 13* specifies the principal local authorities for the purposes of any election of a member of a board by the electors of more than one district. The changes from the present Schedule result from the changes prescribed above.

Clause 14 makes consequential revocations.
