THE HOSPITAL EMPLOYMENT (SECRETARIAL AND CLERICAL OFFICERS) REGULATIONS 1952, AMENDMENT NO. 3

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Hospitals Act 1926, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Hospital Employment (Secretarial and Clerical Officers) Regulations 1952, Amendment No. 3, and shall be read together with and deemed part of the Hospital Employment (Secretarial and Clerical Officers) Regulations 1952* (hereinafter referred to as the special regulations).
- (2) These regulations shall be deemed to have come into force on the 1st day of January 1955.

- 2. (1) Regulation 4 of the special regulations (as amended by regulation 3 of the Hospital Employment (Secretarial and Clerical Officers) Regulations 1952, Amendment No. 1) is hereby revoked, and the following regulation substituted:
- "4. (1) Subject to the provisions of regulations 5 to 7 hereof, a whole time secretarial or clerical officer shall receive a yearly rate of salary according to the scale of salary from time to time determined in each case by the Grading Committee, with the approval of the Minister, that scale being one of the thirteen following:

- (2) The Hospital Employment (Secretarial and Clerical Officers) Regulations 1952, Amendment No. 1, are hereby revoked.
- 3. (1) This regulation shall apply to every whole time secretarial or clerical officer whose yearly rate of salary for any period after the 31st day of December 1954 has been determined by the Grading Committee before the date on which these regulations are notified in the *Gazette*.
- (2) Where the yearly rate of salary for any period referred to in subclause (1) of this regulation is one of the rates shown in the first column (headed "Old Rate") of the conversion table set out in subclause (4) of this regulation, being a rate subject to the general increase provided for by the Hospital Employment Regulations 1952, Amendment No. 2*, there shall be payable for the same period to the officer concerned, in place of the rate in the first column, the yearly rate of salary shown opposite to that rate in the second column (headed "New Rate") of the table, being a rate that in accordance with regulation 5 of these regulations is not subject to that general increase.
- (3) The yearly rate of salary payable in accordance with subclause (2) of this regulation may be paid without further determination by the Grading Committee, but nothing in this regulation shall preclude the Grading Committee from making any subsequent determination in accordance with the special regulations in respect of any officer to whom this regulation applies.

(4) The conversion table referred to in subclause (2) of this regulation is as follows:

- 4. (1) Regulation 11 of the special regulations (as amended by regulation 3 (1) of the Hospital Employment (Secretarial and Clerical Officers) Regulations 1952, Amendment No. 2) is hereby amended as follows:
 - (a) By omitting from paragraph (a) of subclause (1) and also from paragraphs (b) and (c) of the same subclause the expression "11s. 6d,", and substituting in each case the expression "13s.":

- "£912 12s.", and substituting the expression "£1,045".

 (2) Regulation 3 of the Hospital Employment (Secretarial and Clerical Officers) Regulations 1952, Amendment No. 2, is hereby revoked.
- 5. The remuneration provided for in these regulations shall not be subject to the general wage increase prescribed by regulation 3 (2) of the Hospital Employment Regulations 1952, Amendment No. 1* (as amended by regulation 3 of the Hospital Employment Regulations 1952, Amendment No. 2†)".

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations prescribe new scales of salaries for secretarial and clerical officers employed by Hospital Boards. The new rates incorporate the general wage increase previously granted, as well as providing some additional remuneration with effect from 1 January 1955.

As the actual rate of salary applicable to each officer is normally determined by the Secretarial and Clerical Officers' Salaries Grading Committee, special provision is made to convert the rates payable under existing determinations to those payable under the new scales without reference to the Grading Committee.
