**THE HOSPITAL EMPLOYMENT (DENTAL OFFICERS)  
REGULATIONS 1951**

ORDER IN COUNCIL

THE HON. K. J. HOLYOAKE PRESIDING IN COUNCIL

PURSUANT to the Hospitals Act, 1926, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

---

REGULATIONS

1. (1) These regulations may be cited as the Hospital Employment (Dental Officers) Regulations 1951, and shall be read together with and deemed part of the Hospital Employment Regulations 1948\* (hereinafter referred to as the principal regulations).

(2) For the purposes of regulation 5 of the principal regulations, these regulations shall be deemed to form a Part of the principal regulations.

*Commencement*

2. (1) Except where these regulations otherwise provide, such of the provisions of these regulations as have the effect of increasing the rates of salaries, wages, and other emoluments and increments payable in respect of the classes of persons whose positions are specified in these regulations shall be deemed to have come into force on the 1st day of April, 1950.

(2) Except as provided in the last preceding subclause, these regulations shall come into force on the day after the date of their notification in the *Gazette*.

*Interpretation*

3. In these regulations, unless the context otherwise requires,—

“Dental surgeon of special scale” means a whole time dental officer who has been qualified for not less than three years and whose position is for the purposes of these regulations designated by the Board with the approval of the Minister as that of a dental surgeon of special scale; and includes a whole time dental officer who is carrying out the duties of a senior dental surgeon or a first assistant dental surgeon and would have been designated as a senior dental surgeon or a first assistant dental surgeon, as the case may be, if

he had had ten years' experience in the practice of dentistry ; and includes any dental surgeon whose rate of salary is determined under clause 3 of the Schedule to regulation 4 of these regulations :

“ First assistant dental surgeon ” means a whole time dental officer who has had not less than ten years' experience in the practice of dentistry and who had been appointed by the Board to assist the senior dental surgeon and in his absence to discharge his duties :

“ Junior dental surgeon ” means a whole time dental officer who either—

(a) Has been qualified for less than three years ; or

(b) Has been qualified for three years or more and has not been appointed to any other position specified in the schedule to regulation 4 hereof :

“ Practice of dentistry ” has the same meaning as in the Dentists Act, 1936 :

“ Qualified ” means possessing a qualification which entitles the holder to registration in New Zealand under the Dentists Act, 1936 :

“ Senior dental surgeon ” means a whole time dental officer who has had not less than ten years' experience in the practice of dentistry and who has been appointed by the Board as the officer in charge of the Board's dental services or of the dental department of an institution :

“ Whole time dental officer ” means a person who is registered under the Dentists Act, 1936, and is employed in any position designated in the schedule to regulation 4 hereof and who devotes his whole working time to the duties of his position, save that a person shall not be excluded from the definition of a whole time dental officer by reason only of the fact that he engages in dental work outside those duties if that work is of an occasional nature and undertaken on the footing that, except so far as the Board with the approval of the Minister otherwise determines, all fees or other remuneration payable therefor are received by the Board.

#### *Scales of Salaries for Whole Time Dental Officers*

4. The scales of salaries applicable to whole time dental officers shall be those set out in the Schedule appended to this regulation, namely :—

5. The Board in making a determination as to the salary of a dental surgeon of special scale shall have regard to the nature and importance of the duties and responsibilities of the position as well as to the qualifications, experience, and ability of the officer, and any such determination when approved by the Minister shall be effective only so long as the duties and responsibilities of the position remain substantially the same and the officer in respect of whom the determination was made continues to hold the position.

*Annual Leave and Holiday Leave*

6. (1) Leave of absence on full pay for recreational purposes shall be granted to the respective classes of whole time dental officers according to the following scale, namely:—

(2) The number of days shown in the last preceding subclause is to be reckoned in consecutive days' leave (including Saturdays and Sundays, but excluding the public holidays, or substituted succeeding days, where applicable, prescribed in subclause (5) of this regulation that may fall during a period of leave).

(3) A Board may permit leave to be taken in two periods.

(4) When the employment of a whole time dental officer ceases, he shall be paid salary in lieu of leave in respect of any annual leave or portion of annual leave accrued due to him.

(5) In addition to annual leave granted in accordance with this regulation, each whole time dental officer shall be allowed leave on full pay on the following public holidays—namely, Christmas Day, Boxing Day, New Year's Day, Good Friday, Easter Monday, Anzac Day, Sovereign's Birthday, Labour Day, and the holiday observed in the locality as Anniversary Day :

Provided that, when any of the above named public holidays that can fall on a Saturday or a Sunday so falls, the next succeeding day (not being a Sunday) which is not one of the said public holidays or observed as a substituted holiday under this proviso shall be allowed :

Provided further that any whole time dental officer may be required to work on any of the above named public holidays or substituted succeeding days, where applicable, if he is allowed an equivalent holiday on a later day convenient to the Board.

#### *Sick Leave*

7. (1) Where a whole time dental officer is granted leave of absence on account of sickness or injury not arising out of and in the course of his employment (hereinafter referred to as sick leave), he shall be entitled to full pay according to the scale set out in the Schedule to this regulation.

(2) The length of service for the purposes of the schedule means the aggregate period of service, whether continuous or intermittent, in the employ of a Board, a separate institution, or the Crown, or of two or more of such employers.

(3) The total period of sick leave with full pay set out in the schedule may consist of one or more periods. Sick leave with full pay for each period allowed is to be reckoned in consecutive days (including Saturdays, Sundays, and the public holidays, or substituted succeeding days, where applicable, hereinbefore specified that may fall during a period of sick leave).

(4) The total period of sick leave with full pay to which a whole time dental officer is entitled as set out in the schedule shall be computed in respect of his whole length of service.

(5) Where in the opinion of a Board a whole time dental officer in its employ is incapacitated by sickness or injury arising out of and in the course of his employment it shall be permissible for the Board to continue to pay his full salary during incapacity :

Provided that the prior written approval of the Director-General shall be obtained for any such payment beyond a period of three months :

Provided further that the period in respect of which salary is paid in accordance with the provisions of this subclause shall not be regarded as sick leave with pay for the purposes of the foregoing provisions of this regulation.

*Transport*

8. (1) Where a whole time dental officer has been called for any period of duty outside his normal hours of work actual and reasonable expenses incurred in transport to and from that duty shall be paid by the Board.

(2) Where a whole time dental officer is required to use his own motor car for the purposes of his work, the Board may pay him a mileage allowance or, in lieu thereof, a commuted allowance, in either case at a rate and subject to conditions approved by the Minister.
