THE HOSPITAL EMPLOYMENT (ORTHOPAEDIC TECHNICIANS) REGULATIONS 1963, AMENDMENT NO. 3

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Hospitals Act 1957, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Hospital Employment (Orthopaedic Technicians) Regulations 1963, Amendment No. 3, and shall be read together with and deemed part of the Hospital Employment (Orthopaedic Technicians) Regulations 1963* (hereinafter referred to as the special regulations).
- 2. (1) The scales of salaries and wages specified in the Schedule to regulation 4 of the special regulations (as substituted by regulation 3 of these regulations) shall be deemed to have come into force on the dates respectively shown under the headings of the columns therein headed "Yearly Rate of Salary on and from 26 August 1964" and "Yearly Rate of Salary on and from 1 August 1965".
- (2) Except as otherwise provided, these regulations shall be deemed to have come into force on the 26th day of August 1964.
- 3. Regulation 4 of the special regulations is hereby amended by revoking the Schedule to subclause (1) (as substituted by regulation 4 of the Hospital Employment (Orthopaedic Technicians) Regulations 1963, Amendment No. 2), and substituting the following Schedule:

- "(b) The maximum yearly rates specified in paragraph (a) of this clause are subject to the provisions of paragraphs (c) and (d) of this clause.
- "(c) Where a person appointed as a journeyman has had at least 12 months' experience in a related trade after completing his apprenticeship in that trade, the Board may, at its discretion, pay him the salary for the second year after three months' service on the salary for the first year.
- "(d) The salary of a journeyman who has not completed an apprenticeship either in a related trade or in an orthopaedic department shall not be advanced beyond the rate for the first year until he has served such time as would have been necessary to complete such an apprenticeship.

- "(f) The yearly rates specified in the foregoing provisions of this clause are subject to the provisions of paragraph (g) of this clause.
- "(g) Subject to the prior approval of the Director-General, a commencing salary higher than the first-year salary may be paid having regard to the age, educational qualifications, and experience of the person to be appointed as a trainee."
- (2) Regulation 4 of the Hospital Employment (Orthopaedic Technicians) Regulations 1963, Amendment No. 2 is hereby revoked.
- 4. (1) The special regulations are hereby further amended by revoking regulation 6 (as substituted by regulation 5 of the Hospital Employment (Orthopaedic Technicians) Regulations 1963, Amendment No. 2), and substituting the following regulation:

"Lodging Allowances for Certain Trainees

"6. Where in the opinion of a Board a trainee is reasonably required by his circumstances to live away from home, the Board may pay him a lodging allowance according to the following scale, namely:

- (2) Regulation 5 of the Hospital Employment (Orthopaedic Technicians) Regulations 1963, Amendment No. 2, is hereby revoked.
- 5. (1) Regulation 11 of the special regulations is hereby amended by revoking the proviso to subclause (1), and substituting the following proviso:

"Provided that, where an employee has completed five years' service as an orthopaedic technician or as a trainee or both, or is in receipt of an annual salary of not less than £1,160 on and from 1 April 1965 and not less than £1,210 on and from 1 August 1965, 21 days' leave of absence on full pay for recreational purposes shall be allowed in respect of each leave year."

(2) This regulation shall be deemed to have come into force on the 1st day of April 1965.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide amended conditions of employment for orthopaedic technicians employed by Hospital Boards.
