THE HOSPITAL EMPLOYMENT (ENGINEERS) REGULATIONS 1963, AMENDMENT NO. 2

ORDER IN COUNCIL

At the Government House at Wellington this 23rd day of June 1965

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Hospitals Act 1957, His Excellency the Governor-General acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Hospital Employment (Engineers) Regulations 1963, Amendment No. 2, and shall be read together with and deemed part of the Hospital Employment (Engineers) Regulations 1963* (hereinafter referred to as the special regulations).

Commencement

- 2. (1) The scales of salaries specified in regulation 4 of the special regulations (as substituted by regulation 3 hereof) shall be deemed to have come into force on the dates respectively shown in the headings of the columns therein headed "Yearly Rate of Salary on and from 1 August 1963", "Yearly Rate of Salary on and from 1 April 1964", and "Yearly Rate of Salary on and from 26 August 1964".
- (2) Regulations 4, 5, and 6 of these regulations shall be deemed to have come into force on the 1st day of August 1963.
- (3) Except as aforesaid or as otherwise specified herein, these regulations shall be deemed to have come into force on the 1st day of April 1965.
- 3. (1) Regulation 4 of the special regulations is hereby amended by revoking subclause (1) (as substituted by regulation 3 of the Hospital Employment (Engineers) Regulations 1963, Amendment No. 1) and substituting the following subclause:

"(1) Subject to the provisions of regulations 5 to 10 of the special regulations (as amended by these regulations), a whole-time engineer shall receive a yearly rate of salary according to the scale of salary from time to time determined in each case by the Grading Committee, with the approval of the Minister, that scale being one of the eight following:

- (2) Regulation 3 of the Hospital Employment (Engineers) Regulations 1963, Amendment No. 1, is hereby revoked.
- 4. The special regulations are hereby further amended by revoking regulation 5 (as substituted by regulation 4 of the Hospital Employment (Engineers) Regulations 1963, Amendment No. 1), and substituting the following regulation:
- "5. Notwithstanding anything to the contrary in regulation 4 hereof, the Grading Committee may, with the approval of the Minister, determine in the case of an engineer who, in the opinion of the Grading Committee, is a person of exceptional qualifications and training or of exceptional experience a yearly rate of salary exceeding the maximum of £2,230 from 1 August 1963 and £2,370 from 1 April 1964 specified in subclause (1) of regulation 4 hereof but in no case exceeding £2,360 from 1 August 1963 or £2,530 from 1 April 1964."
- 5. Regulation 7 of the special regulations (as amended by regulation 6 of the Hospital Employment (Engineers) Regulations 1963, Amendment No. 1) is hereby further amended by omitting from subclause (3) the words "26th day of July 1962" wherever they occur, and substituting in each case the words "1st day of August 1963".

6. Regulation 9 of the special regulations is hereby amended by revoking subclause (3) (as substituted by regulation 7 of the Hospital Employment (Engineers) Regulations 1963, Amendment No. 1), and substituting the following subclause:

"(3) This regulation shall apply to shift engineers whose yearly rate of salary does not exceed £1,290 from 1 August, 1963, £1,310 from 1

April 1964, and £1,355 from 26 August 1964.

7. Regulation 10 of the special regulations is hereby amended by revoking paragraph (e) of subclause (2), and substituting the following

paragraph:

"(e) Notwithstanding the provisions of regulation 5 of the principal regulations, the value of board and lodging shall be computed at the inclusive rate of £4 per week, and, where accommodation additional to a bedroom is provided for the personal use of an engineer, the Director-General shall determine a rate exceeding £4 per week but not exceeding £5 per week and no cleaning services or other requisites, services, or supplies shall be provided by a Board to the personal accommodation of an engineer:

> "Provided that no deduction shall be made from the salary of an engineer who is provided with board and lodging in respect of any period during which he is living away from the accommodation provided for him by a Board on account of

annual leave, sick leave, or special leave."

8. Regulations 4, 6, and 7 of the Hospital Employment (Engineers) Regulations 1963, Amendment No. 1, are hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide amended conditions of employment for engineers employed by Hospital Boards.
