HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Hospitals Act 1957, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Hospital Employment (Dietitians) Regulations 1963, Amendment No. 2 and shall be read together with and deemed part of the Hospital Employment (Dietitians) Regulations 1963* (hereinafter referred to as the special regulations).

Commencement

- 2. These regulations shall be deemed to have come into force on the 1st day of August 1963.
- 3. Regulation 4 of the special regulations is hereby amended by revoking the Schedule to that regulation (as substituted by regulation 3 of the Hospital Employment (Dietitians) Regulations 1963, Amendment No. 1), and substituting the following Schedule:

- 4. The special regulations are hereby further amended by revoking regulation 5 (as substituted by regulation 4 of the Hospital Employment (Dietitians) Regulations 1963, Amendment No. 1), and substituting the following regulation:
- "5. Notwithstanding anything to the contrary in regulation 4 hereof, the Grading Committee may, with the approval of the Minister, determine in the case of a grade dietitian who in the opinion of the Grading Committee is a person of exceptional qualifications and training or of exceptional experience a yearly rate of salary exceeding the maximum specified in regulation 4 hereof of £1,535 on and from 1 August 1963 but in no case exceeding £1,585 on and from that date."
- 5. Regulation 7 of the special regulations (as amended by regulation 6 of the Hospital Employment (Dietitians) Regulations 1963, Amendment No. 1) is hereby further amended by omitting from subclause (3) the words "1st day of April 1961" wherever they occur, and substituting in each case the words "1st day of August 1963".
- 6. Regulations 3, 4, and 6 of the Hospital Employment (Dietitians) Regulations 1963, Amendment No. 1, are hereby revoked.
