**THE HOSPITAL EMPLOYMENT (OCCUPATIONAL

**ORDER IN COUNCIL**

At the Government House at Wellington this 2nd day of August 1955

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Hospitals Act 1926, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

1. (1) These regulations may be cited as the Hospital Employment (Occupational Therapists) Regulations 1952, Amendment No. 3, and shall be read together with and deemed part of the Hospital Employment (Occupational Therapists) Regulations 1952\* (hereinafter referred to as the special regulations).

(2) These regulations shall be deemed to have come into force on the 1st day of January 1955.

2. Regulation 3 of the special regulations is hereby amended by adding to the definition of the term "tuberculosis institution, ward, or annexe" the words "and the term 'tuberculosis ward' includes a ward mainly conducted for the reception and treatment of persons suffering from tuberculosis".

3. (1) The Schedule to regulation 4 of the special regulations (as substituted by regulation 3 of the Hospital Employment (Occupational Therapists) Regulations 1952, Amendment No. 1) is hereby amended by omitting clause 6, and substituting the following clause:

(2) The remuneration provided for by subclause (1) of this regulation shall be subject to the general wage increase prescribed by regulation 3 (2) of the Hospital Employment Regulations 1952, Amendment No. 1\* (as amended by regulation 3 of the Hospital Employment Regulations 1952, Amendment No. 2†).
