THE HOSPITAL EMPLOYMENT (ORTHOPAEDIC TECHNICIANS) REGULATIONS 1957, AMENDMENT NO. 1

ORDER IN COUNCIL

At the Government House at Wellington this 3rd day of December 1957

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Hospitals Act 1926, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Hospital Employment (Orthopaedic Technicians) Regulations 1957, Amendment No. 1, and shall be read together with and deemed part of the Hospital Employment (Orthopaedic Technicians) Regulations 1957* (hereinafter referred to as the special regulations).

(2) These regulations shall be deemed to have come into force on the 19th day of November 1956.

2. Regulation 4 of the special regulations is hereby amended by revoking the Schedule to subclause (1), and substituting the following Schedule:
