THE HOSPITAL EMPLOYMENT (ORTHOPAEDIC TECHNICIANS) REGULATIONS 1963, AMENDMENT NO. 2

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Hospitals Act 1957, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Hospital Employment (Orthopaedic Technicians) Regulations 1963, Amendment No. 2, and shall be read together with and deemed part of the Hospital Employment (Orthopaedic Technicians) Regulations 1963* (hereinafter referred to as the special regulations).

Commencement

- 2. (1) The scales of salaries and wages specified in the Schedule to regulation 4 of the special regulations (as substituted by regulation 4 hereof), shall be deemed to have come into force on the dates respectively shown in the headings of the columns therein headed "Yearly Rate of Salary on and from 1 August 1963", "Yearly Rate of Salary on and from 1 April 1964", and "Yearly Rate of Salary on and from 26 August 1964".
- (2) Regulation 3 of these regulations shall be deemed to have come into force on the 1st day of April 1964.
- (3) Except as aforesaid or as otherwise specified herein, these regulations shall be deemed to have come into force on the 1st day of April 1965.
- 3. Regulation 3 of the special regulations is hereby amended by inserting in paragraph (a) of the definition of the term "foreman", after the words "orthopaedic technicians", the words "or trainees".

- 5. (1) The special regulations are hereby further amended by revoking regulation 6 (as substituted by regulation 5 of the Hospital Employment (Orthopaedic Technicians) Regulations 1963, Amendment No. 1), and substituting the following regulation:

Hospital Employment (Orthopaedic Technicians) Regulations 1963, Amendment No. 2

"Lodging Allowances for Certain Trainees

"6. Where in the opinion of a Board a trainee is reasonably required by his circumstances to live away from home, the Board may pay him a lodging allowance according to the following scale, namely:

- (2) Regulation 5 of the Hospital Employment (Orthopaedic Technicians) Regulations 1963, Amendment No. 1, is hereby revoked.
- 6. The special regulations are hereby further amended by revoking regulation 7, and substituting the following regulation:

"Deduction for Board and Lodging

- "7. (1) Notwithstanding the provisions of regulation 5 of the principal regulations, in respect of any period during which a Board provides an orthopaedic technician or trainee with board and lodging, it shall make a deduction from the salary of the employee concerned at the rate of £4 per week, and, where accommodation additional to a bedroom is provided for the personal use of an orthopaedic technician or trainee, the Director-General shall determine a rate exceeding £4 per week but not exceeding £5 per week and no cleaning services or other requisites, services, or supplies shall be provided in either case by a Board to the personal room of an orthopaedic technician or trainee.
- "(2) No deduction shall be made from the salary of any employee who is provided with board and lodging, in respect of any period during which the employee is living away from the accommodation provided by the Board, on account of annual leave, sick leave, or special leave."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide amended conditions of employment for orthopaedic technicians employed by Hospital Boards.
