HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Hire Purchase and Credit Sales Stabilisation Regulations 1957, Amendment No. 27, and shall be read together with and deemed part of the Hire Purchase and Credit Sales Stabilisation Regulations 1957\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall be deemed to have come into force on the 2nd day of September 1974.
- 2. Amending commencement date of Amendment No. 26—Regulation 1 of the Hire Purchase and Credit Sales Stabilisation Regulations 1957, Amendment No. 26, is hereby amended by revoking subclause (2), and substituting the following subclause:

"(2) These regulations shall come into force on the 4th day of September 1974."
