# ORDER IN COUNCIL

At Wellington this 29th day of May 1989

### Present:

THE RIGHT HON. G. W. R. PALMER PRESIDING IN COUNCIL

PURSUANT to section 24 of the New Zealand Horticulture Export Authority Act 1987, His Excellency the Governor-General, acting on the recommendation of the Minister of Agriculture and the Minister of Overseas Trade and Marketing made in compliance with section 25 of that Act, and by and with the advice and consent of the Executive Council, hereby makes the following order.

## **ORDER**

- 1. Title and commencement—(1) This order may be cited as the Horticultural Prescribed Products (Citrus Fruits) Order 1989.
- (2) This order shall come into force on the 28th day after the date of its notification in the Gazette.
  - 2. Interpretation—In this order,—
    - "The Act" means the New Zealand Horticulture Export Authority Act 1987:
    - "Citrus fruit" means the products specified in clause 3 of this order.
- **3. Certain citrus fruits declared to be prescribed products**—The following products are hereby declared to be prescribed products for the purposes of the New Zealand Horticulture Export Authority Act 1987:

Sweet orange (Citrus sinensis).
Sour orange (Citrus aurantium).
Lemon (Citrus limon).
Grapefruit (Citrus paradisi).
Mandarin clementine (Citrus reticulata).
Mandarin satsuma (Citrus unshiu).
Tangelo (Citrus paradisi x Citrus reticulata).
Tangor (Citrus sinensis x Citrus reticulata).

- **4. Citrus fruit to be subject to export licensing**—Citrus fruit are hereby declared to be subject to export licensing in accordance with Part III of the Act.
- **5. Recognised product group**—The Citrus Export Council is hereby declared to be the product group recognised under section 25 of the Act as suitable to carry out the functions of a recognised product group in relation to citrus fruit.

## EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on the 28th day after the date of its notification in the Gazette, declares 8 types of citrus fruit to be prescribed products for the purposes of the New Zealand Horticulture Export Authority Act 1987. They are to be subject to export licensing in accordance with Part III of that Act, and the Citrus Export Council is declared to be the relevant recognised product group.
