ORDER IN COUNCIL

PURSUANT to section 24 of the New Zealand Horticulture Export Authority Act 1987, His Excellency the Administrator of the Government, acting on the recommendation of the Minister of Agriculture and the Minister of Overseas Trade and Marketing made in compliance with section 25 of that Act, and by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Horticultural Prescribed Products (Blackcurrants) Order 1990.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. Interpretation-In this order-

"The Act" means the New Zealand Horticulture Export Authority Act 1987:

"Blackcurrants" means the product specified in clause 3 of this order.

3. Blackcurrants declared to be prescribed product—The following product is hereby declared to be a prescribed product for the purposes of the New Zealand Horticulture Export Authority Act 1987:

Blackcurrants (Ribes spp.).

4. Blackcurrants to be subject to export licensing—Blackcurrants are hereby declared to be subject to export licensing in accordance with Part III of the Act on and from the 1st day of September 1990.

5. Recognised product group—Blackcurrants N.Z. Ltd. is hereby declared to be the product group recognised under section 25 of the Act as suitable to carry out the functions of a recognised product group in relation to blackcurrants.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on the day after the date of its publication in the *Gazette*, declares blackcurrants to be a prescribed product for the purposes of the New Zealand Horticulture Export Authority Act 1987 and declares Blackcurrants N.Z. Ltd. to be the relevant recognised product group.

The order also declares that blackcurrants are to be subject to export licensing in accordance with Part III of the New Zealand Horticulture Export Authority Act 1987 (although it should be noted that export licences will not be required before the later of (i) the date on which the export marketing strategy for blackcurrants comes into force under section 29 of the Act, or (ii) 1 September 1990).

Blackcurrants are presently subject to export licensing under the Berryfruit Marketing Licensing Regulations 1983, but from 1 September 1990 are to be removed from the ambit of those regulations by the Berryfruit Marketing Licensing Regulations 1983, Amendment No. 5.
