THE HYDATIDS REGULATIONS 1970, AMENDMENT NO. 3

PURSUANT to the Hydatids Act 1968, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement-(1) These regulations may be cited as the Hydatids Regulations 1970, Amendment No. 3, and shall be read together with and deemed part of the Hydatids Regulations 1970* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the Gazette.

2. Restriction on movement of dogs into certain hydatids control districts-(1) Regulation 23A of the principal regulations (as inserted by regulation 6 of the Hydatids Regulations 1970, Amendment No. 2) is hereby amended by inserting, after the words "any hydatids control district", the words ", or part thereof,". (2) The proviso to the said regulation 23A is hereby amended by

adding to paragraph (c) the word "; or".

(3) The proviso to the said regulation 23A is hereby further amended by adding the following paragraphs:

"(d) At all times while the dog is in the district, it is confined either---

"(i) Within a vehicle; or

"(ii) For stud purposes only, within a breeding kennel approved for the purposes of this regulation by the Hydatids Control Authority for the district; or

- "(e) The dog is being used by the Customs Department or the Police Department; or
- "(f) The dog is a guide dog or seeing-eye dog, that is being used by a blind person."

(4) The list of hydatids control districts to which the said regulation 23A applies is hereby amended—

- (a) By omitting from the list of districts in the North Island the words "Central Hawke's Bay", the words "excluding the City of Gisborne", and the words "Hokianga-Whangaroa":
- (b) By inserting in the list of districts in the North Island, before the words "Bay of Islands", the words "Auckland excluding all parts thereof that are not within the boundaries of Waiheke County":
- (c) By inserting in the list of districts in the North Island, after the word "Waipawa", the word "Waipukurau":
- (d) By omitting from the list of districts in the South Island, Stewart Island, and Chatham Islands, the word "Ashley" and the word "Waipara":
- (e) By inserting in the list of districts in the South Island, Stewart Island, and Chatham Islands, after the words "Golden Bay", the word "Hurunui".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend regulation 23_{Λ} of the Hydatids Regulations 1970 (which restricts the movement of dogs into certain hydatids control districts) by---

(a) Exempting certain dogs from the regulation; and

(b) Amending the list of hydatids control districts to which the regulation applies.
