**ORDER IN COUNCIL**

At the Government Buildings at Wellington this 19th day of February 1963

Present:

THE HON. J. R. MARSHALL PRESIDING IN COUNCIL

PURSUANT to the Milk Act 1944, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

**ORDER**

1. (1) This order may be cited as the Hutt Valley and Bays Metropolitan Milk District Order 1963.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. The Hutt Valley and Bays Metropolitan Milk District, as constituted by the Hutt Valley and Bays Metropolitan Milk District Order 1958,\* shall hereafter consist of the areas described in the Schedule hereto; and the boundaries of the said district shall be those specified in the said Schedule.

3. The Hutt Valley and Bays Metropolitan Milk District Order 1958 is hereby revoked.

**SCHEDULE**

**THE HUTT VALLEY AND BAYS METROPOLITAN MILK DISTRICT**

ALL that area situated in the Wellington Land District comprising the City of Lower Hutt, the Boroughs of Petone, Eastbourne, Upper Hutt, Tawa, and Porirua, the Point Howard and Petone Wharves, and the County of Hutt excluding that portion lying generally west of a line commencing at a point on the eastern boundary of Section 105, Ohariu District, due east of the northern corner of Lot 1, D.P. 16132, and proceeding northerly generally along the generally eastern boundaries of the said Section 105 and of Sections 106, 114, 115, 116, 117, and 118,

Ohariu District, to the southern boundary of the land shown on plan D/514, lodged in the District Land Registry Office at Wellington; thence westerly, northerly, and easterly generally along the southern, western, and northern boundaries of the land shown in the said plan D/514, to the eastern boundary of Section 119, Ohariu District; thence northerly generally along the generally eastern boundaries of the said Section 119 and the eastern and north-eastern boundaries of the land shown on D.P. 9126 to the south-eastern boundary of the land shown on plan B271, lodged in the District Land Registry Office at Wellington; thence north-easterly and north-westerly along the south-eastern and generally north-eastern boundaries of the land shown on the said plan B271 to mean high-water mark, Cook Strait; as the said area is delineated on the plan marked NZMB 180/1, deposited in the office of the New Zealand Milk Board, Anvil House, Wellington, and thereon edged blue.
