REGULATIONS

1. Title, commencement, and application—(1) These regulations may be cited as the Immigration Amendment Regulations (No. 4) 1999,

and are part of the Immigration Regulations 1991* ("the principal regulations").

(2) These regulations come into force on 1 August 1999.

(3) These regulations apply in respect of the issue of a residence visa or the grant of a residence permit on or after 1 August 1999, irrespective of when the application for the visa or permit was made.

2. Migrant levy—The Third Schedule of the principal regulations is amended by revoking Part IV (as substituted by regulation 3 of the Immigration Amendment Regulations 1998), and substituting the new Part IV set out in the Schedule of these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 August 1999, amend the Immigration Regulations 1991 to increase the migrant levy payable under regulation 32BB of those regulations. For an individual, the migrant levy is increased from \$180 to \$220. The maximum levy payable in respect of family members included in a single application is increased from \$720 to \$880.
