ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 3 of the Import Control Act 1988, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Import Control Regulations 1988, Amendment No. 4, and shall be read together with and deemed part of the Import Control Regulations 1988* (hereinafter referred to as the principal regulations).

(2) Subject to subclause (3) of this regulation these regulations shall come into force on the 1st day of October 1989.

(3) Subclause (3) and subclause (4) of regulation 2 of these regulations shall come into force on the 1st day of November 1989.

2. Amendments to principal regulations—(1) The First Schedule to the principal regulations is hereby amended by omitting the Tariff Items

and descriptions of classes of goods specified in the First Schedule to these regulations.

(2) The First Schedule to the principal regulations is hereby further amended by inserting, in their appropriate numerical order, the Tariff Items and descriptions of classes of goods specified in the Second Schedule to these regulations.

(3) The First Schedule to the principal regulations is hereby further amended by omitting the Tariff Items and descriptions of classes of goods specified in the Third Schedule to these regulations.

(4) The First Schedule to the principal regulations is hereby further amended by inserting, in their appropriate numerical order, the Tariff Items and descriptions of classes of goods specified in the Fourth Schedule to these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the First Schedule to the Import Control Regulations 1988. The amendments set out in the First and Second Schedules to these regulations come into force on 1 October 1989 and those set out in the Third and Fourth Schedules come into force on 1 November 1989.
