



## **Instant Kiwi (Instant Game) Amendment Rules 2006**

Pursuant to section 243 of the Gambling Act 2003, the Minister of Internal Affairs approves the Instant Kiwi (Instant Game) Amendment Rules 2006, as set out in the Schedule, which were made by the New Zealand Lotteries Commission on 24th August 2006.

### **Rules**

- 1 Title**  
These rules are the Instant Kiwi (Instant Game) Amendment Rules 2006.
- 2 Commencement**  
These rules come into force on the day after the date of their notification in the *Gazette*.

**3 Principal rules amended**

These rules amend the Instant Kiwi (Instant Game) Rules 1992.

**4 Prize Reserve Fund**

Rule 13(1) is amended by revoking paragraph (b) and substituting the following paragraph:

“(b) any prize money in respect of a prize-bearing ticket remaining unclaimed on the expiry of 12 months after the close of the game to which the prize-bearing ticket relates, calculated in accordance with the following formula:

$$a \times b - c$$

where—

- a is the total value of prizes or total prize pool in respect of the game
- b is the proportion of tickets sold in respect of the game
- c is the total value of prizes claimed in respect of the game.”

### **Explanatory note**

*This note is not part of the rules, but is intended to indicate their general effect.*

These rules, which come into force on the day after the date of their notification in the *Gazette*, amend the Instant Kiwi (Instant Game) Rules 1992. The rules clarify that only prize money for Instant Kiwi tickets that have been sold and which remain unclaimed for 12 months after the close of a game to which the tickets relate is payable into the prize reserve fund.
