**THE INDUSTRY LICENSING (ROPE AND TWINE  
MANUFACTURE) NOTICE 1939.**

PURSUANT to section 14 of the Industrial Efficiency Act, 1936, I, Daniel Giles Sullivan, Minister of Industries and Commerce, do hereby give notice as follows :—

1. This notice may be cited as the Industry Licensing (Rope and Twine Manufacture) Notice 1939.

2. The industry to which this notice relates is the following :—  
The manufacture of rope and twine as herein defined.

3. For the purpose of this notice the manufacture of rope and twine shall be deemed to include the carding, hackling, twisting, laying, polishing, stranding, closing, plaiting, braiding, preparing, spinning, and otherwise converting vegetable bast and leaf fibres, including phormium, sisal, manila hemp, Italian hemp, European hems, jute and flax, and similar hard and soft fibres into yarn, thread, twine, rope, and cordage.

4. On and after such one of the respective dates specified herein as is applicable to the case, the said industry shall be carried on only pursuant to a license issued under Part III of the Industrial Efficiency Act, 1936, and in conformity with the terms and conditions of such license.

5. The dates hereinbefore referred to shall be the following, namely :—

(a) In the case of persons who on the date of notification hereof in the *Gazette* are lawfully engaged in carrying on business in the industry to which this notice relates the said date shall (subject to the next succeeding subclause (b) hereof) be the 1st day of December, 1940, or such earlier or later date (if any) as may hereafter be specified by a further notice under section 14 of the Industrial Efficiency Act, 1936, given before the said 1st day of December, 1940.

- (b) In the case of a person, being an incorporated company, limited by shares which on the date of notification hereof in the *Gazette* is lawfully engaged in carrying on the business to which this notice relates, the said date shall be whichever of the following dates shall first happen—namely, the 1st day of December, 1940, or the fourteenth day after the date upon which notice is given to the company by the Bureau of Industry setting out that in the opinion of the Bureau there has, since the date of notification hereof in the *Gazette*, been a substantial change in the beneficial ownership of the shares of the company, and that the Bureau has determined accordingly that the company shall not carry on without a license.
- (c) In all other cases the said date shall be the date of notification hereof in the *Gazette*.
