**THE INDUSTRY LICENSING (BITUMINOUS ROOFING
MATERIAL MANUFACTURE) NOTICE 1939.**

PURSUANT to section 14 of the Industrial Efficiency Act, 1936, I, Daniel Giles Sullivan, Minister of Industries and Commerce, do hereby give notice as follows :—

1. This notice may be cited as the Industry Licensing (Bituminous Roofing Material Manufacture) Notice 1939.

2. The industry to which this notice relates is the following :—

The manufacture for sale of bituminous roofing material as herein defined.

3. For the purpose of this notice the manufacture of bituminous roofing material shall be deemed to include the manufacture of any material which is suitable for use in the building of any roof or portion thereof and which is in the form of a sheet of whatsoever size consisting of any felt, paper, or other fibrous material, including paper felt, rag felt, rag and paper felt, asbestos felt, asbestos paper, hessian, or *Phormium tenax* fibre, or any combinations thereof, impregnated or coated or impregnated and coated with any bituminous material intended to render it resistant to water or weather.

4. On and after such one of the respective dates specified herein as applicable to the case, the said industry shall be carried on only pursuant to a license issued under Part III of the Industrial Efficiency Act, 1936, and in conformity with the terms and conditions of such license.

5. The dates hereinbefore referred to shall be the following, namely :—

(a) In the case of persons who on the date of notification hereof in the *Gazette* are lawfully engaged in carrying on business in the industry to which this notice relates the said date shall (subject to the next succeeding subclause (b) hereof) be the 1st day of December, 1939, or such earlier or later date (if any) as may hereafter be specified by a further notice under section 14 of the Industrial Efficiency Act, 1936, given before the said 1st day of December, 1939 :

- (b) In the case of a person, being an incorporated company, limited by shares which on the date of notification hereof in the *Gazette* is lawfully engaged in carrying on the business to which this notice relates, the said date shall be whichever of the following dates shall first happen—namely, the 1st day of December, 1939, or the fourteenth day after the date upon which notice is given to the company by the Bureau of Industry setting out that in the opinion of the Bureau there has, since the date of notification hereof in the *Gazette*, been a substantial change in the beneficial ownership of the shares of the company, and that the Bureau has determined accordingly that the company shall not carry on without a license :
- (c) In all other cases the said date shall be the date of notification hereof in the *Gazette*.
