



THE IMMIGRATION (ENTRY PERMITS) REGULATIONS 1978

ORDER IN COUNCIL

At the Government House at Wellington this 16th day of October 1978

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Immigration Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Immigration (Entry Permits) Regulations 1978.

(2) These regulations shall come into force on the date of their notification in the *Gazette*.

2. Interpretation—In these regulations “the Act” means the Immigration Act 1964.

3. Forms of entry permits—(1) Every temporary permit granted under section 14 of the Act to any person permitted to enter New Zealand for the purpose of undertaking employment shall be issued in Form 1 in the Schedule to these regulations.

(2) Every temporary permit, other than a student’s permit, granted under section 14 of the Act to any person permitted to enter New Zealand for any purpose authorised by that section, except the undertaking of employment, shall be issued in Form 2 in the Schedule to these regulations.

(3) Every permit granted under section 15 of the Act to any person permitted to enter New Zealand for the purpose of taking up permanent residence in New Zealand shall be issued in Form 3 in the Schedule to these regulations.

4. Application of regulations—These regulations shall apply notwithstanding anything in the Immigration Restriction Regulations 1930.
