THE IMMIGRATION REGULATIONS 1987, AMENDMENT NO. 1

ORDER IN COUNCIL

At Wellington this 14th day of December 1987

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 150 of the Immigration Act 1987, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Immigration Regulations 1987, Amendment No. 1, and shall be read together with and deemed part of the Immigration Regulations 1987* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Exemptions from need for arrival and departure cards—The principal regulations are hereby amended by inserting, after regulation 22, the following regulation:

“22A. The following persons are exempt from the requirement to surrender an arrival card pursuant to section 126 (1) (a) of the Act and the requirement to surrender a departure card pursuant to section 126 (2) (a) of the Act:

- “(a) Members of the armed forces of any country, and members of the crew of any craft used for the transporting to New Zealand of members of the armed forces of any country, who—
- “(i) Are, under section 11 (1) (b) of the Act, temporarily exempt from the requirement to hold a permit; and
 - “(ii) Arrive in New Zealand in a craft that is set aside for or being used by the armed forces of any country:
- “(b) Passengers and members of the crew of any seagoing vessel who are, under section 11 (1) (c) of the Act, temporarily exempt from the requirement to hold a permit:
- “(c) Members of the crew of any commercial aircraft who are, under section 11 (1) (e) of the Act, temporarily exempt from the requirement to hold a permit.”

3. Exemption from fees—Part II of the Third Schedule to the principal regulations is hereby amended by adding the following clause:

“3. *Visas subject to visa fee waiver agreements*—No fee shall be payable by a citizen of any country with which New Zealand maintains a reciprocal visa fee waiver agreement in respect of any application for or issue of a visa of a kind that is the subject of the agreement.”

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Immigration Regulations 1987 by—

- (i) Exempting certain persons from the need to supply immigration arrival and departure cards (members of visiting forces, passengers and crew of ships not staying in New Zealand for more than 28 days, and crew of commercial aircraft not staying in New Zealand for more than 7 days); and
- (ii) Exempting from the payment of visa fees citizens of those countries with which New Zealand has reciprocal visa fee waiver agreements.
