THE INDUSTRIAL RELATIONS (RELATED INDUSTRIES) NOTICE 1985

DAVID BEATTIE, Governor-General

PURSUANT to section 162 (2) of the Industrial Relations Act 1973, I, The Honourable Sir David Stuart Beattie, the Governor-General of New Zealand, hereby give the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Industrial Relations (Related Industries) Notice 1985.

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. Related industries—The industries specified in the Schedule hereto are hereby declared to be related to one another.

SCHEDULE

Cl. 2

Driving Industry

Drivers of horsedrawn vehicles and motor vehicles, drivers' assistants, driving instructors, bus conductors, bus couriers, hostesses on any motor vehicle, stable attendants, stablemen, grooms, drivers employed in the carrying industry, drivers of implements used on road construction or repair work or on formation or excavation work generally being implements drawn by horse or hauled or propelled by motor or tractor, tractor drivers, garage employees in the road transport industry.

Stores, Packing, and Warehouse Industry

1. Workers, being storepersons and packers (other than in retail shops), store porters, warehouse employees (other than clerks, commercial travellers, or drivers); and including such workers employed in or in connection with any wholesale motor spirits installation, wholesale petroleum installation, or wholesale oil installation.

2. Employees in any wholesale fruit store or in any wholesale produce store or in any wholesale fruit and produce store; including wool, grain, hide, or seed employees.

3. Automotive parts workers and trainees and stores workers substantially employed in the wholesale trade.

4. Without prejudice to the generality of paragraphs 1 to 3, the stores, packing, and warehouse industry includes warehouse workers (other than drivers or clerks) and stores workers (other than in retail shops), being—

- (a) Workers employed in the freight consolidating and forwarding industry (other than clerks, commercial travellers, or drivers); or
- (b) Workers (other than auctioneers) in the fruit merchandising industry or in the produce merchandising industry or in the fruit and produce merchandising industry; or
- (c) Workers employed in the wholesale wine trade or the wholesale spirits trade or the wholesale wine and spirits trade; or
- (d) Workers substantially employed in any tool store or tool yard or in any steel store or steel yard or in the store or yard of any garage or in any engineering store or engineering yard; or
- (e) Workers operating forklift trucks, mobile cranes or gantry cranes, or like equipment (other than on a public carriageway) for receiving, handling, stacking, stowing, transporting, supplying, delivering, despatching, or moving materials or commodities of any kind; or

(f) Van salesworkers enagaged in the wholesale trade; or

(g) Packers of any goods (other than in a retail shop).

5. Notwithstanding anything in paragraphs 1 to 4, the stores, packing, and warehouse industry does not include—

(a) Tradesmen wholly or substantially engaged in a trade; or

(b) Workers in cool stores or cold stores or freezing chambers.

Retail Industry

- 1. Persons employed in the sale of goods at retail; including-
- (a) Butchers, cakeshop assistants, fishmongers, fruiterers, mixed business assistants, grocers, small goods workers, or slaughterers; and
- (b) Workers employed in grocery warehouses in the preparation and sale of meat in supermarkets; and
- (c) Workers employed—

(i) In the slaughtering of stock; or

(ii) In connection with the preparation, sale, or delivery of meat or meat products in any wholesale or retail establishment, bacon factory, small goods factory, delicatessen, or butcher's shop (including any butcher's shop forming part of the same premises as a freezing works); and

- (d) Greengrocers, retail shop assistants, tobacconists' assistants, buyers, floorwalkers, retail shop managers, branch managers, departmental managers, section heads, trainee managers, other workers in charge, shopmen, pharmaceutical chemists, floral tribute workers, lending library assistants and attendants, book exchange employees, video hire employees, salesmen, specialty salespersons, suit hire attendants, dispensers of medicines, pharmacy workers (which includes pharmacists, unqualified assistants, pharmacy interns, dispensary assistants, pharmacy aids, and retail pharmacy shop assistants); and
- (e) Collectors, travellers, deliverymen, hawking-cartmen, roving cartworkers, porters, packers, storemen, lounge attendants, hairdressers, hairdressers' assistants, hairworkers, wigmakers, beauticians, beauty consultants, salon attendants, windowdressers, ticket writers, commercial artists, scenic artists, display artists, copywriters, advertising writers, checkout stand employees, auto

partspersons, auctioneers' assistants, mannequin models, door-todoor salespersons, retailers' bulk store assistants, storepersons, packers, deliverypersons, interior decorating advisers, staff training officers, lift attendants, cleaners, window cleaners, and watchpersons.

2. Except for workers engaged in the manufacture of small goods (including the processing or packaging of meat) in a factory that is manufacturing exclusively for a retail shop situated in or within the precincts of the premises of a freezing works, the retail industry does not include the activities of workers employed in any department of a meat freezing works.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

An industrial union may be registered under the Industrial Relations Act 1977 only in relation to employers or workers engaged in any specified industry or related industries in New Zealand.

This notice, which is made under section 162 (2) of the Industrial Relations Act 1973, declares the 3 industries specified in the Schedule to this notice, namely, the driving industry, the stores, packing, and warehouse industry, and the retail industry, to be related to one another.
