**THE IMMIGRATION RESTRICTION REGULATIONS 1930,
AMENDMENT NO. 4**

THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL

PURSUANT to the Immigration Restriction Act, 1908, His Excellency the Governor-General, acting by and with the consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Immigration Restriction Regulations 1930, Amendment No. 4.

2. These regulations shall be read together with and deemed part of the Immigration Restriction Regulations 1930* (hereinafter referred to as the principal regulations).

3. These regulations shall come into force on the day following notification in the *Gazette* of the making thereof.

4. Form 14, prescribed by Regulation 20 of the principal regulations, as the said form is replaced by Regulation 4 of the Immigration Restriction Regulations 1930, Amendment No. 3,* is hereby revoked, and form 14 as set forth in the Schedule hereto is substituted therefor.

5. The reference in Regulation 20 of the principal regulations to form 14 shall be deemed to be a reference to the form in the Schedule hereto.

6. The Immigration Restriction Regulations 1930, Amendment No. 3,* are hereby revoked.
