ORDER IN COUNCIL

At the Government House at Wellington, this 14th day of June, 1950

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Immigration Restriction Act, 1908, His Excellency the Governor-General, acting by and with the consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Immigration Restriction Regulations 1930, Amendment No. 6, and shall be read together with and deemed part of the Immigration Restriction Regulations 1930* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day following the date of their notification in the Gazette.

2. (1) The Schedule to the principal regulations is hereby amended by revoking Form 14, as substituted by Regulation 4 of the Immigration Restriction Regulations 1930, Amendment No. 4[†], and substituting the form set out in the Schedule hereto.

(2) The regulations cited as the Immigration Restriction Regulations 1930, Amendment No. 4⁺, are hereby revoked.
